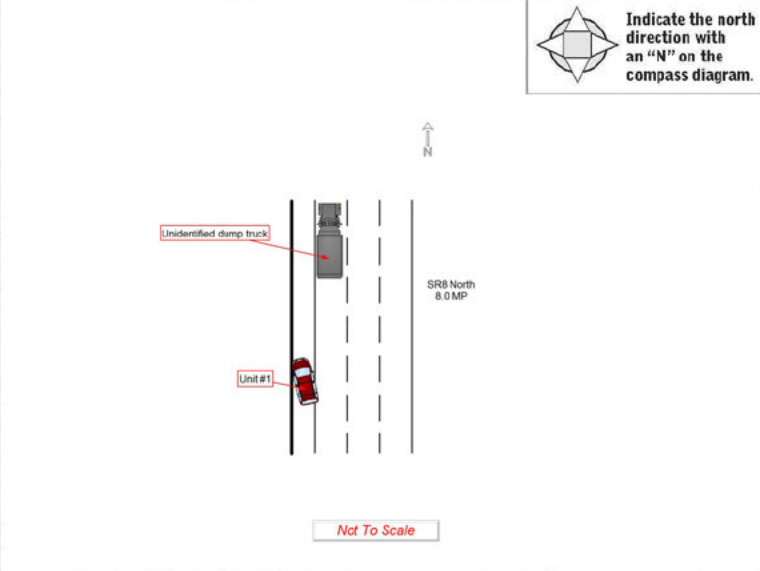

NARRATIVE

Unit #1 was northbound on SR 8 in the left lane. The driver of Unit #1 states a dump truck cut her off from the right, causing her to swerve to the left to avoid a collision with the dump truck. The front left of Unit #1 struck the concrete median in the process. Video of the accident is available but does not show what occurred immediately before the accident. The full-sized dump truck was not identified.
