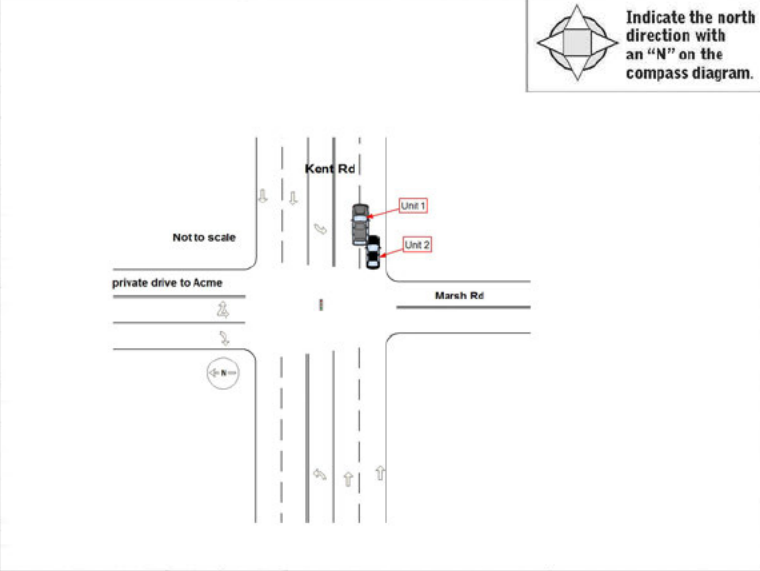

UNIT 1 WAS EB IN THE LEFT LANE OF KENT RD. UNIT 2 WAS EB IN THE RIGHT LANE. UNITS HAD JUST STARTED AHEAD AS THEIR TRAFFIC SIGNAL TURNED GREEN. AFTER CLEARING THE INTERSECTION, UNIT 1 ATTEMPTED TO CHANGE LANES TO THE RIGHT LANE. UNIT 1 STRUCK UNIT 2 AFTER FAILING TO MAKE A SAFE LANE CHANGE. UNIT 1 FLED THE SCENE AFTERWARD AN OH3 WAS NOT OBTAINED FROM UNIT 2.

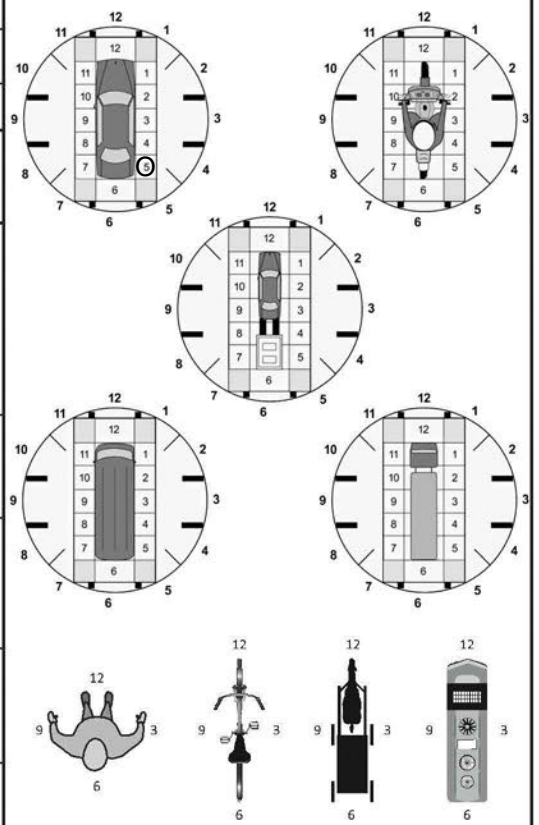

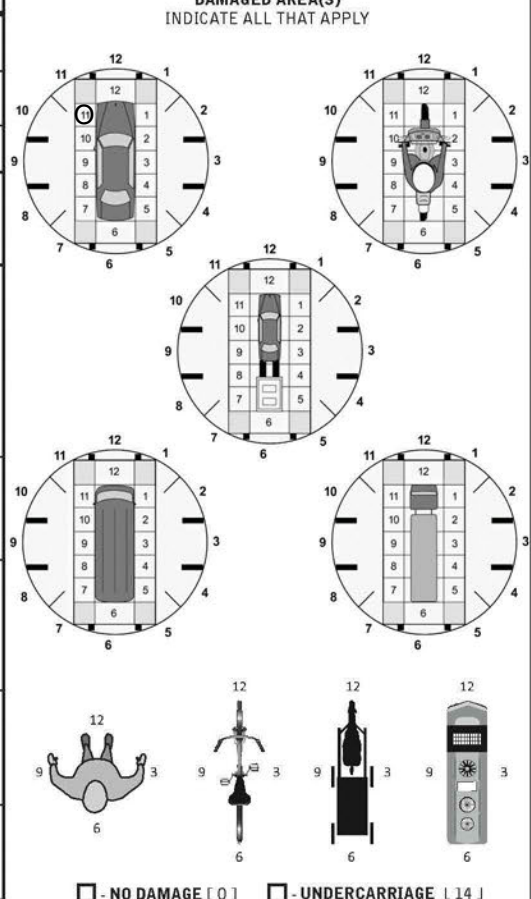

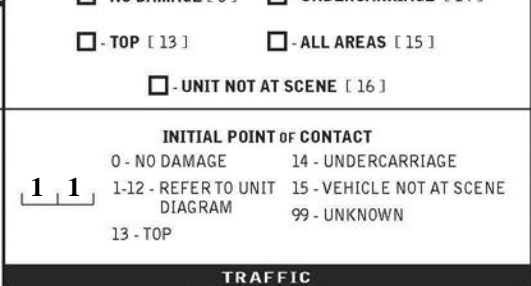
