DESCRIBE WHAT HAPPENED

**- UNIT #1 WAS DRIVING THRU THE PARKING LOT AT 3265 KENT ROAD. UNIT #1 STRUCK A US POSTAL MAILBOX AND THEN CONTINUED STRIKING THE GARAGE BUILDING AT SLOW MUFFLER + BRAKES. INSIDE THE CLOSED GARAGE A PARKED VEHICLE WAS STRUCK BY PIECES OF THE DAMAGED GARAGE DOOR AND WALL. NO EVIDENCE OF BRAKE FAILURE WAS FOUND ON UNIT #1. UNIT #1 WAS TOWED TO JOE'S TOWNS. UNIT #1 DRIVER TRIPPED AT SCENE BY SLOW EMS. NO INJURIES REPORTED.**

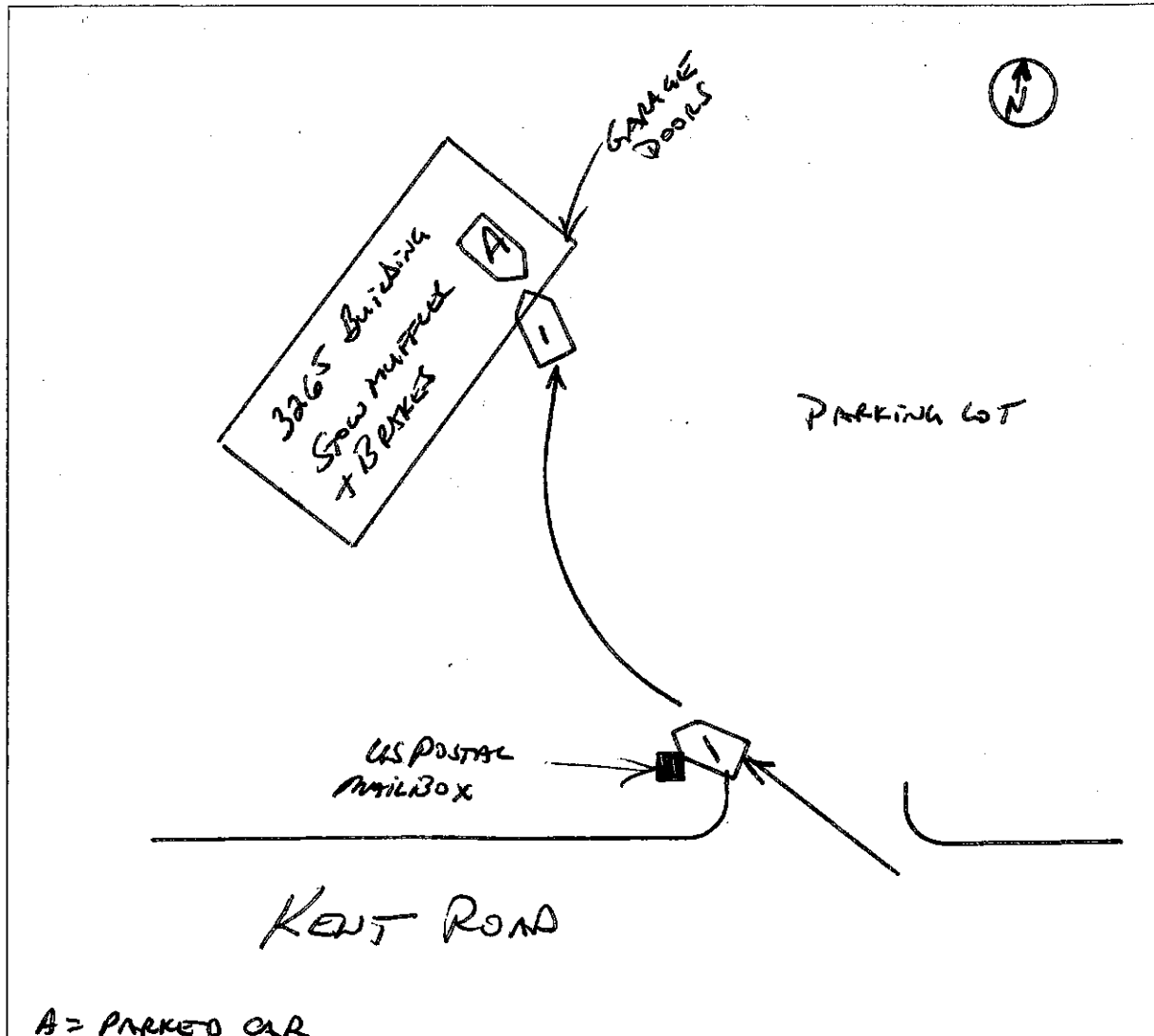

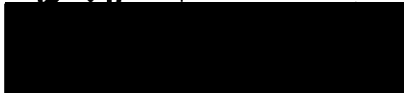
