


Unit 1 went off the roadway and came to rest after striking the patio fence and furniture at 3254 Kent Road (Pancho and Lefty's). Unit 2 was spun around and came to rest after striking the utility pole on the southeast corner of the intersection. OH-3's not obtained as all occupants were transported to local hospitals.
