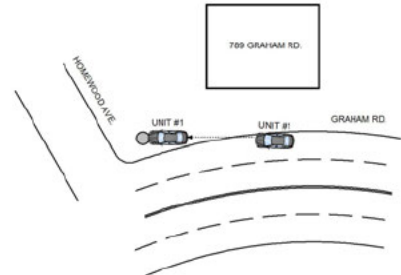
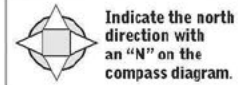

UNIT #1 WAS TRAVELING WESTBOUND IN THE RIGHT-LANE ON GRAHAM RD. NEAR 789 GRAHAM RD. THE DRIVER OF UNIT #1 STATED HIS VISION WAS TEMPORARILY OBSTRUCTED DUE TO THE HEADLIGHTS OF ANOTHER VEHICLE TRAVELING IN THE OPPOSITE DIRECTION. AS A RESULT, UNIT #1 DROVE OFF OF THE ROAD TO THE RIGHT AND STRUCK A UTILITY POLE HEAD-ON LOCATED IN FRONT OF 789 GRAHAM RD.
