 Driver for unit 2 did not show insurance as of this time.

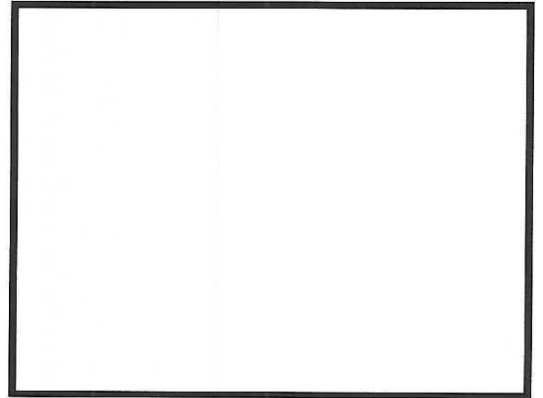

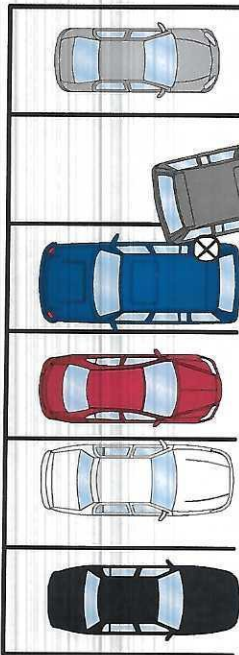
