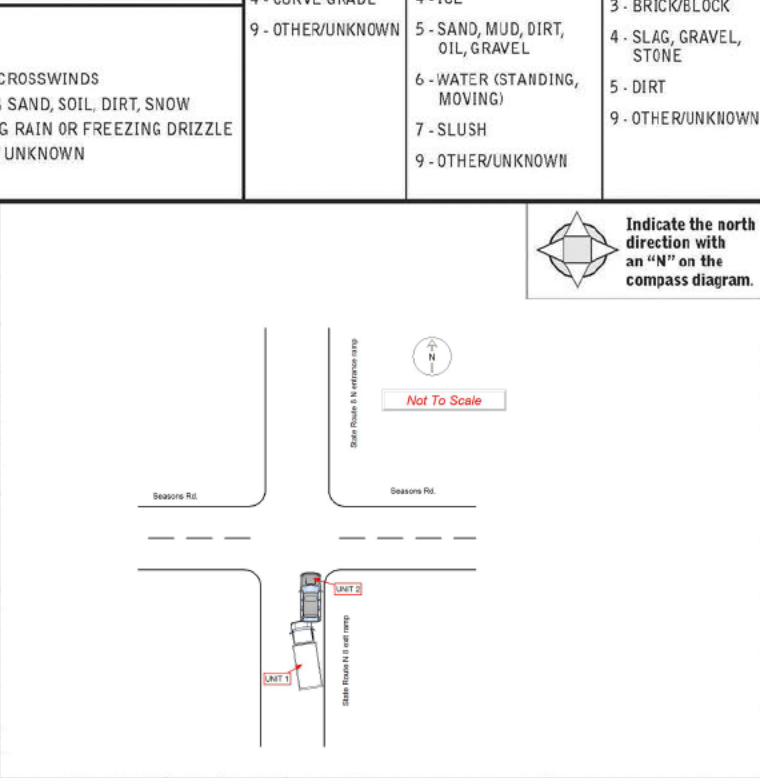

Unit 2 began to enter the intersection to make a right onto Seasons Rd. He broke due to another vehicle traveling east on Seasons Rd. failing to yield to the red light. Unit 1 failed to maintain an assured clear distance ahead and struck Unit 2.**

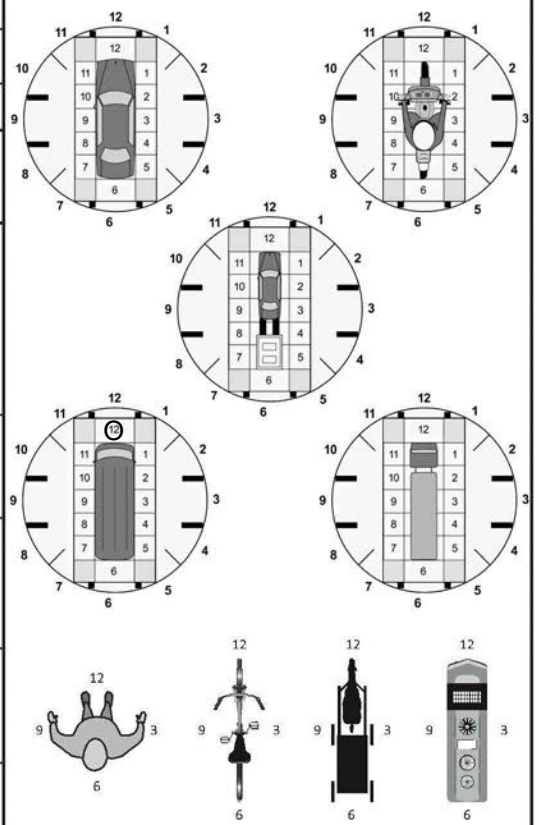

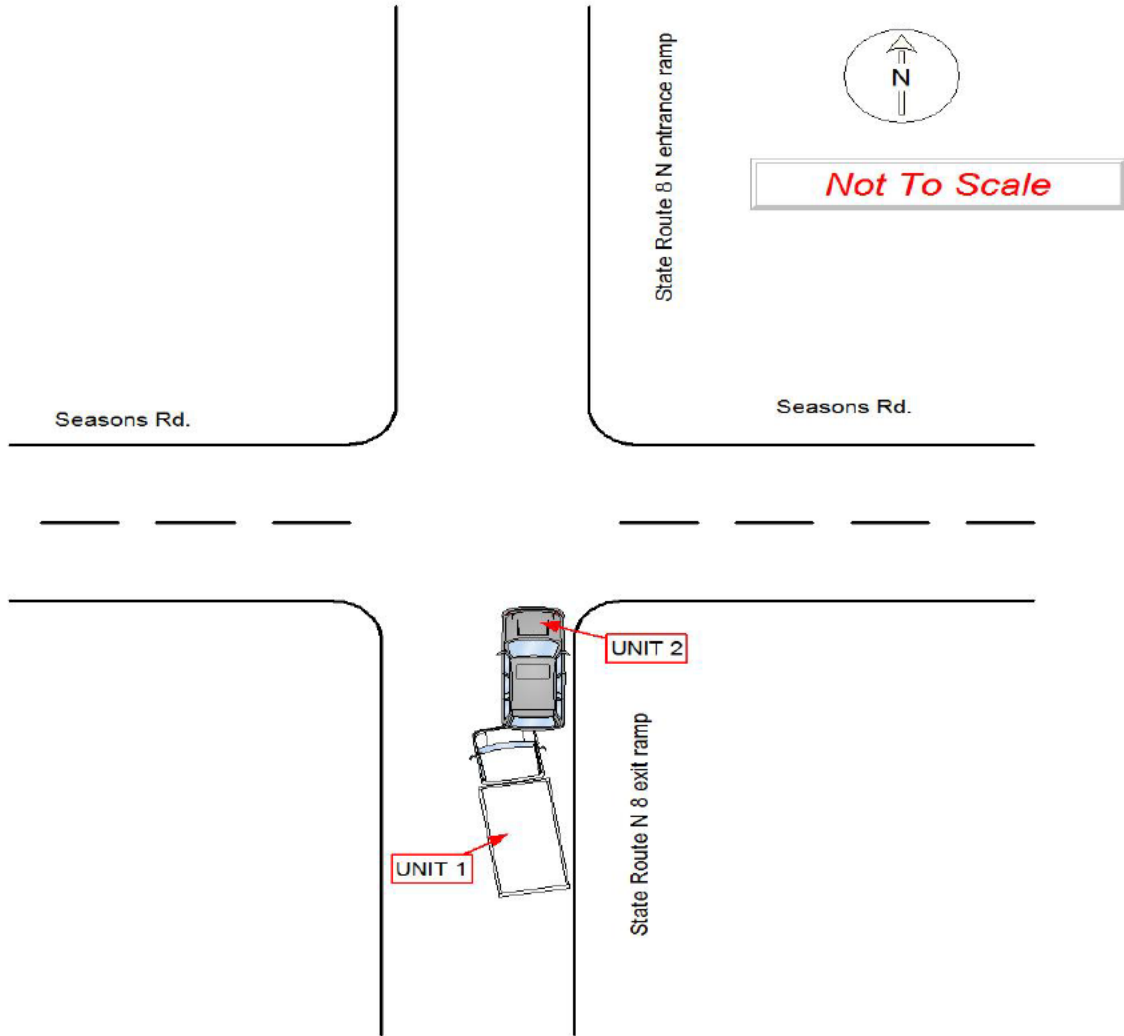
