

DESCRIBE WHAT HAPPENED

BOTH UNITS WERE WEST-BOUND ON KENT ROAD IN THE FAR RIGHT LANE APPROACHING DARROW ROAD. UNIT-2 WAS STOPPED BEHIND THE TRAFFIC BACKED-UP FROM THE RED LIGHT. UNIT-1 ATTEMPTED TO STOP BEHIND UNIT-2 BUT DID NOT MAINTAIN ASSURED CLEAR DISTANCE TO BE ABLE TO STOP IN TIME WITH THE WEATHER CONDITIONS. UNIT-2 WAS ALSO OCCUPIED BY LATISHA'S 8-YEAR OLD SON IN THE BACK SEAT. THERE WERE NO INJURIES. BOTH UNITS MOVED INTO A PARKING LOT PRIOR TO ARRIVAL.

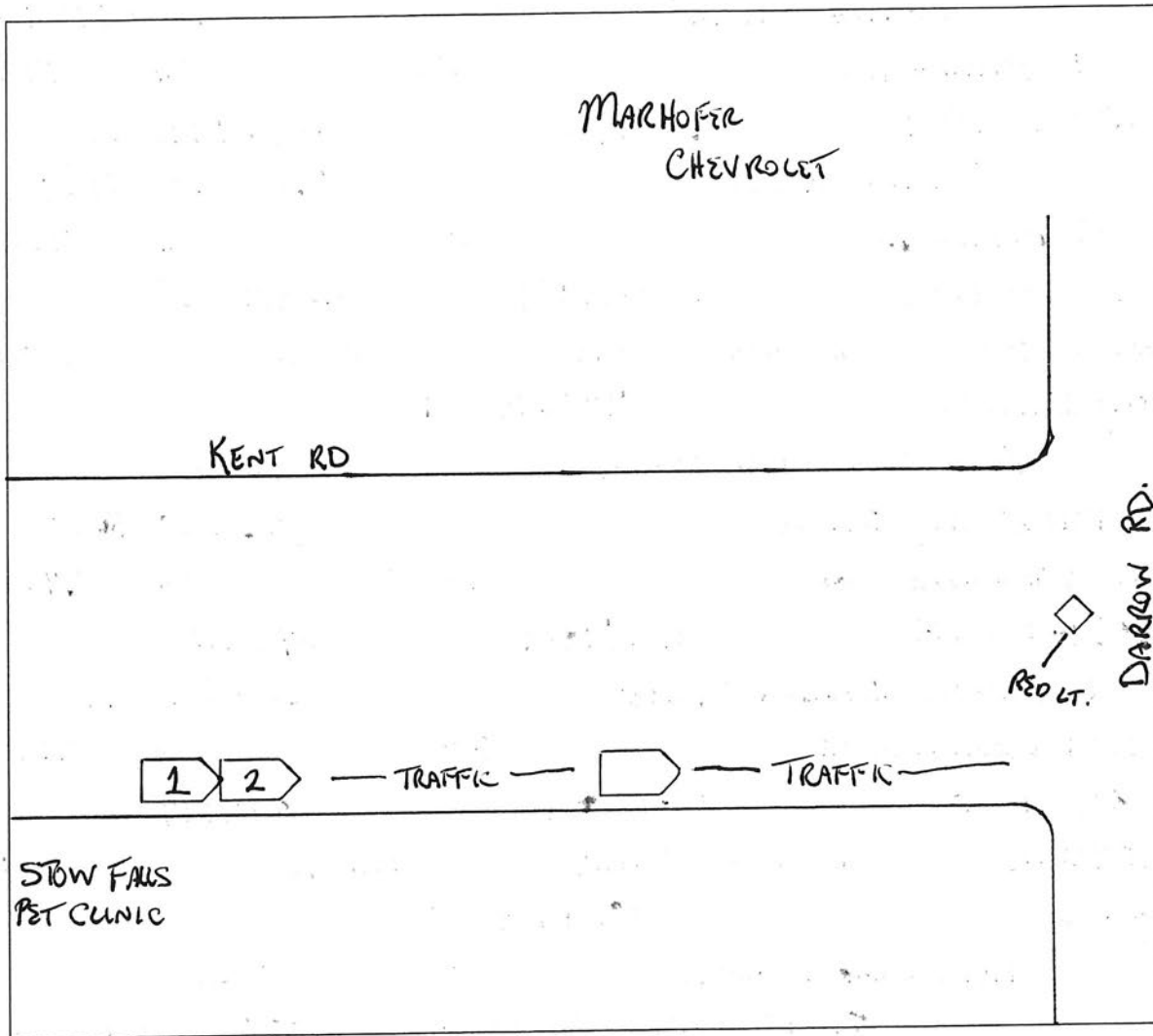
