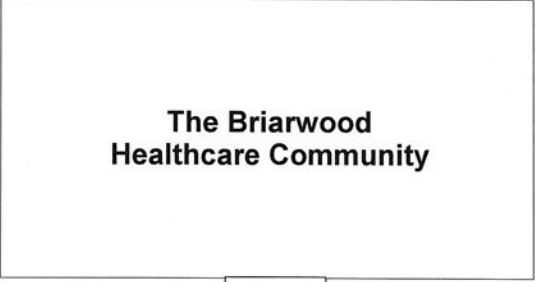

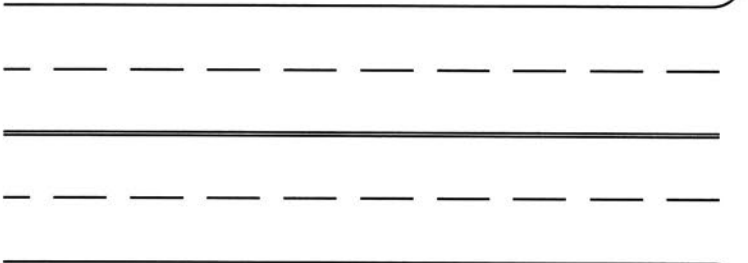


Overhang (Clearance)
