Jared didn't notice the damage until he got out of his car when he got home. He immediately drove back to Fitworks to look for the suspect vehicle. No vehicles were parked behind the spot he was originally in. He looked for damaged cars in the lot and saw a white Jeep Grand Cherokee with Ohio plate HBL7256. The vehicle had a small chip of white paint missing on the rear bumper but was parked one row south of where his car originally was. He said the Jeep took off suddenly as he got near it.

Jared noticed there is a camera at Wendy's that may have captured the crash. I went to Wendy's and the employee advised me they don't have access to their surveillance and gave me the number (419-289-3628) for corporate. I called their corporate and one of their employees looked at their surveillance. The employee advised the camera that faces north mostly just shows the cars going through the drive-thru. It was not able to pick up the crash.
