Seminaro's vehicle has a noteworthy dent on the rear left bumper, while Noe incurred no damages. NOTE: Seminaro stated Noe declined a report at the time for lack of damages.

Per Noe, both parties were backing out at the same time and there was a notable sun glare. Noe confirmed she did not file a report on scene but spoke with Ofc. Kidd on station on Tuesday.

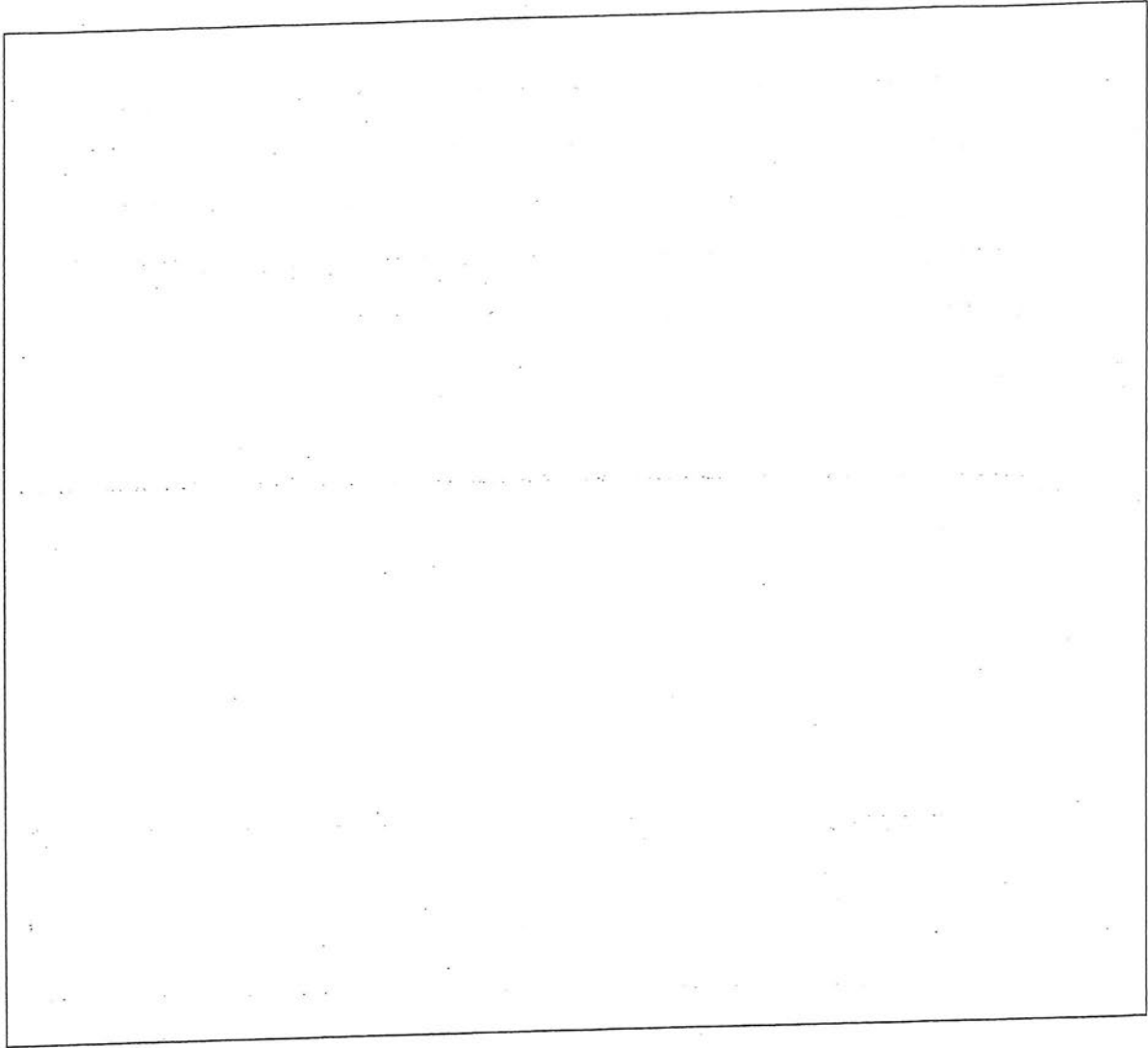
