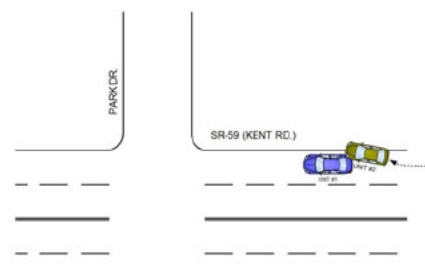
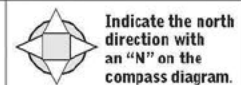

**UNIT #1 WAS HEADING WESTBOUND ON SR-59 IN THE RIGHT-LANE NEAR PARK DR. UNIT #2 WAS DIRECTLY BEHIND UNIT #1. UNIT #1 STOPPED IN TRAFFIC DUE TO A SEPARATE CRASH. UNIT #2 FAILED TO ASSURE CLEAR DISTANCE BEHIND UNIT #1. AS A RESULT, THE FRONT DRIVER SIDE OF UNIT #2 STRUCK THE REAR PASSENGER SIDE OF UNIT #1. UNIT #2 THEN RAN OFF THE ROAD TO THE RIGHT AND BECAME DISABLED ON THE CURB.**

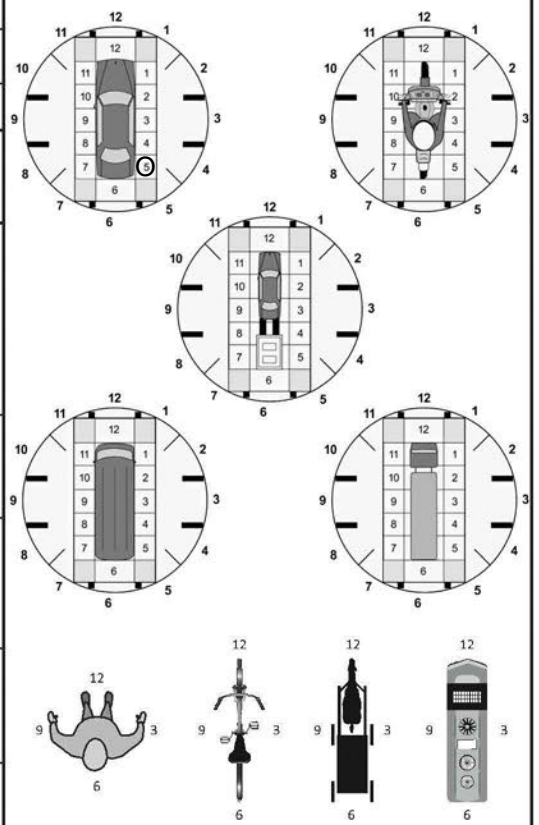
