NARRATIVE <p>Unit 1 was traveling north on State Route 8 near the 8.2-mile marker in icy and rainy conditions. Unit 1 was in the left lane when they failed to control the vehicle. While rotating, Unit 1 crossed over two lanes of travel on the right. Unit 1 struck the guard rail with the front driver's side corner. Then, continued rotating and struck the guard rail again with the rear driver's side corner. After one more rotation, the vehicle came to rest facing east in the right lane of travel.</p>

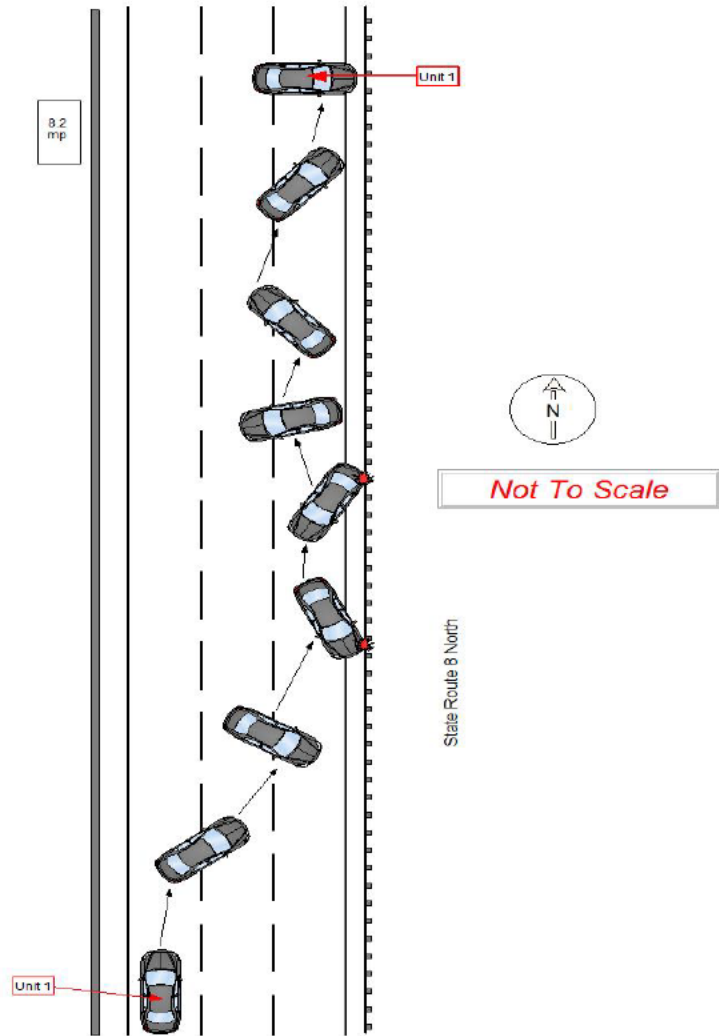
