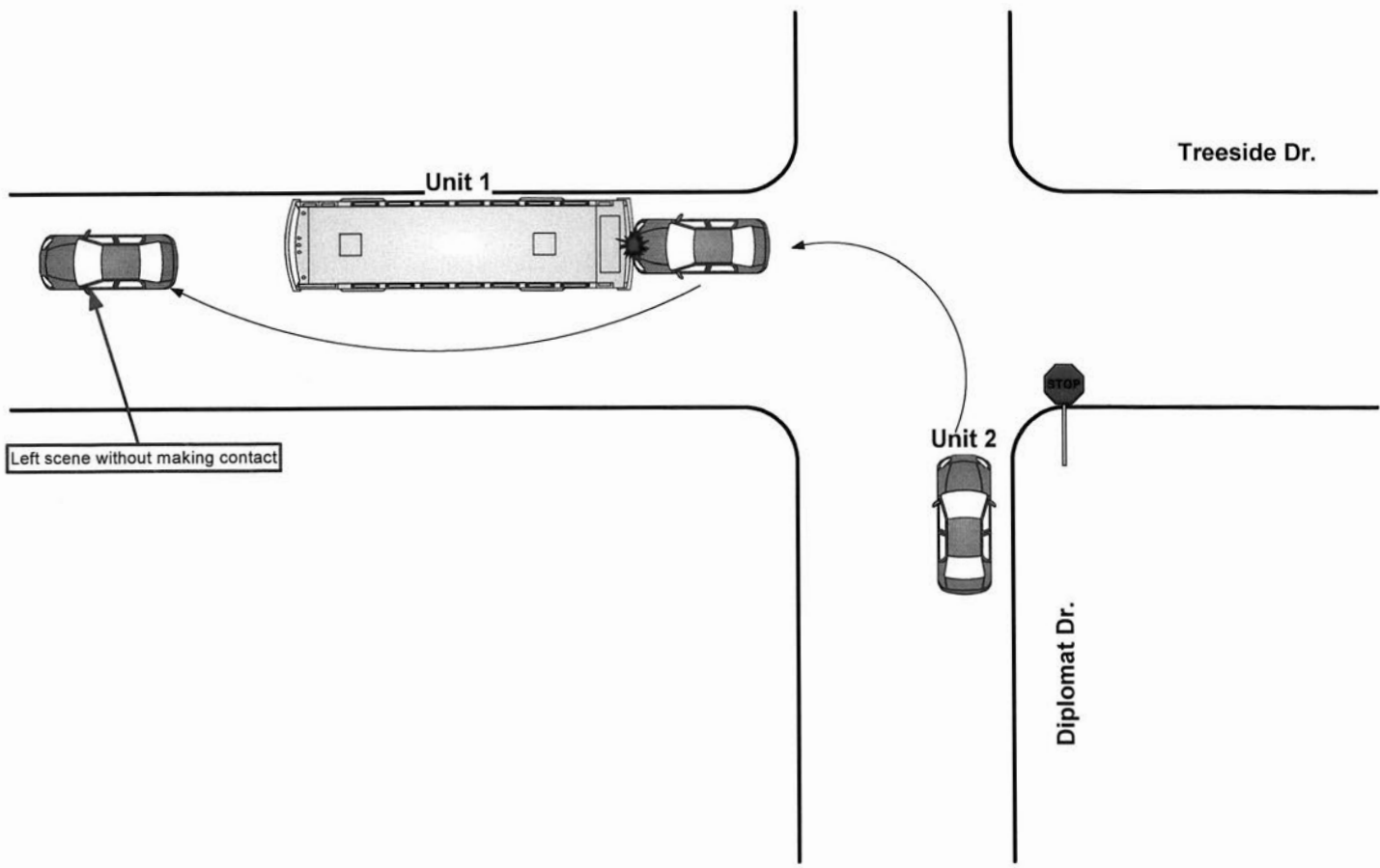

OHIO TRAFFIC CRASH - DIAGRAM/NARRATIVE CONTINUATION

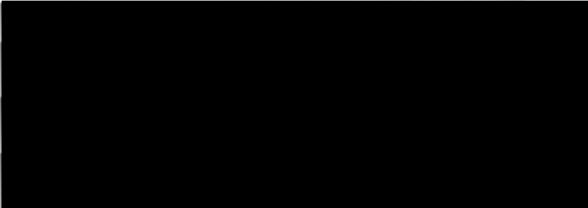
