DESCRIBE WHAT HAPPENED

Unit #1 was N/B on Stow Road and attempted to turn right to go in the driveway, entering the Circle K gas station. Unit #1 failed to maintain control and the vehicle slid off the driveway, over the curb, and collided with two utility poles and an AT&T cable box. Unit #1 also damaged some shrubbery. Unit #1 left the scene without notifying the gas station or police. Unit #1 was described as a white pickup truck (likely a Ford 150) with a roof box and a green upright round trash can (solid) in the bed. The driver was a white male, in his 30s or 40s, and he went to Pump 1 and then inside the store immediately after the crash.

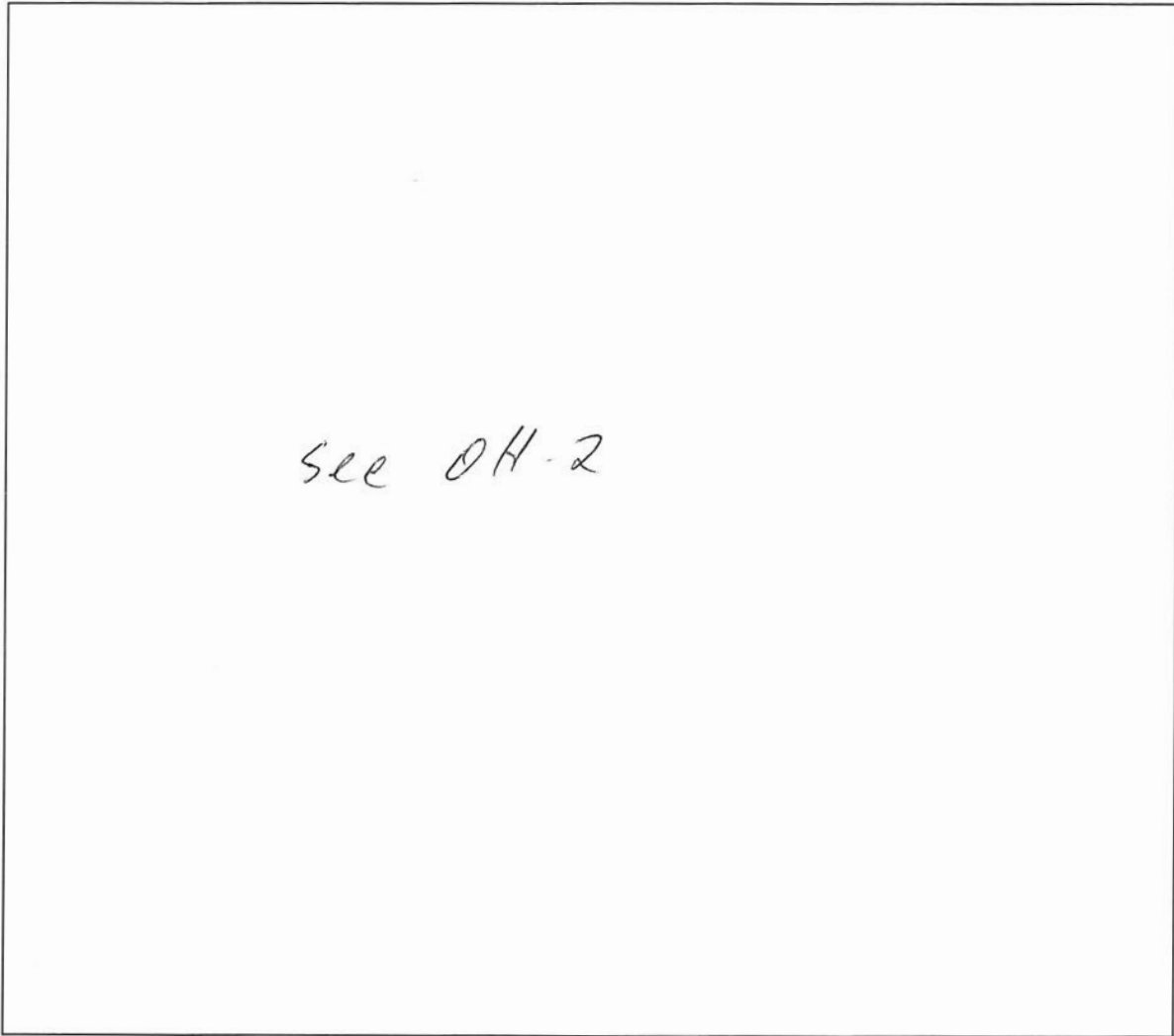

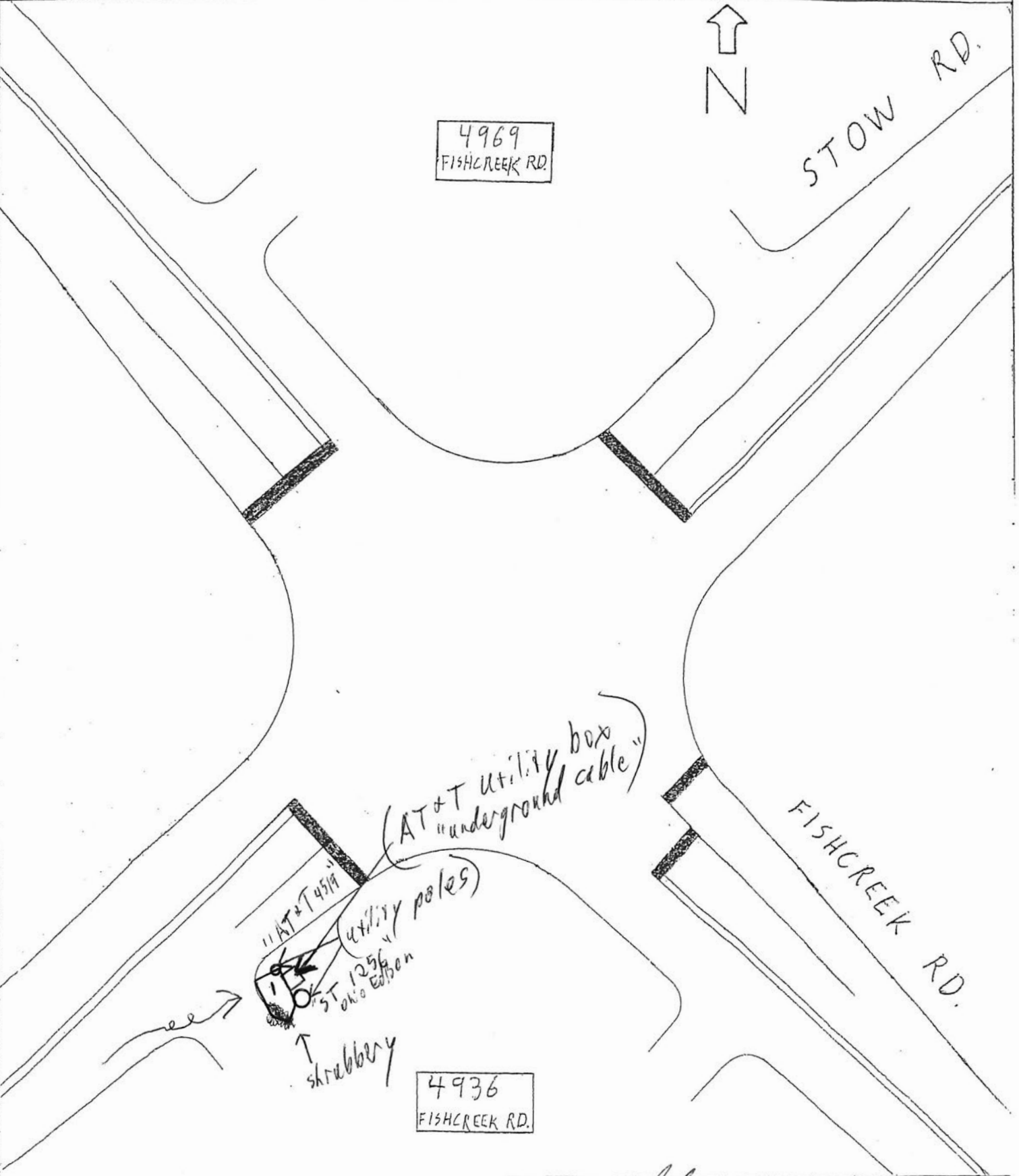
