NARRATIVE Unit 2 is a marked police vehicle. Unit 2 was attempting to initiate a traffic stop on Unit 1 on Steels Corners Rd near the entrance ramp of State Route 8. Unit 1 failed to yield to Unit 2's lights and sirens and a pursuit ensued northbound on State Route 8. Unit 2 performed a successful Pursuit Intervention Technique on Unit 1, striking Unit 1 on the rear driver's side with Unit 2's front push bumper. Unit 1 failed to maintain control of the vehicle causing it to cross over two lanes of travel, and crash into the concrete median at the 13.4 mile post.

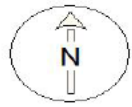
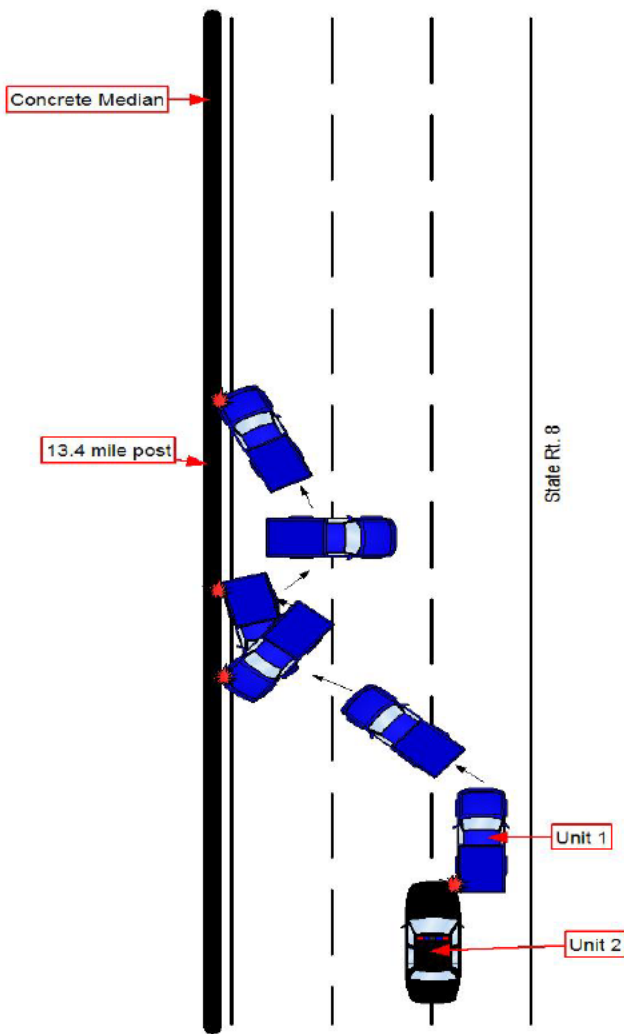


