Neither Unit had recollection of the accident. Officers determined fault by evidence of roadway markings that dictated where the impact occurred. 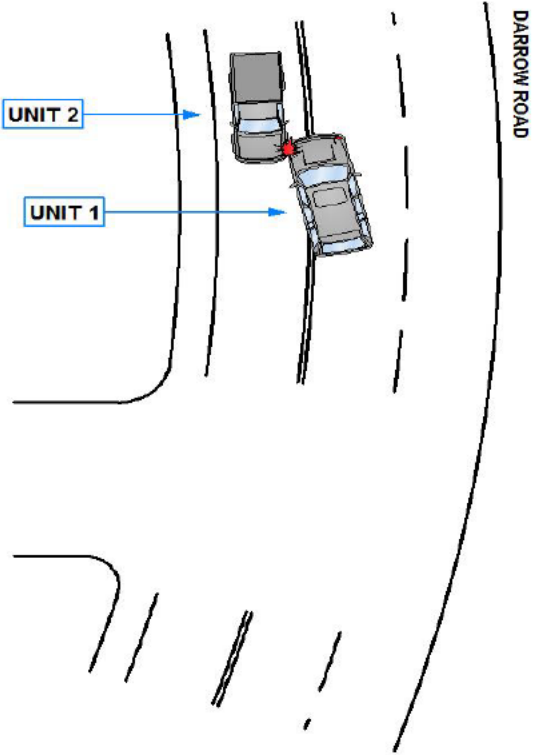
