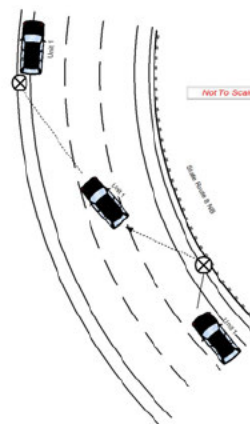

NARRATIVE

Unit 1 was traveling northbound on State Route 8 over the Hudson Dr. bridge approaching the 8.0 MP.

Due to the lower temperatures and the lack of salt on the bridge, ice formed. The driver did not maintain control of the vehicle. They ran off the road to the right and struck the guardrail. They then went across three lanes of traffic, went off the road to the left, and struck the center median before coming to final rest.
