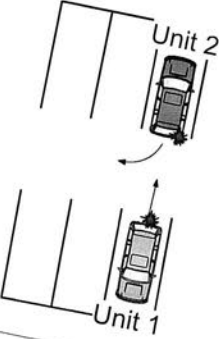
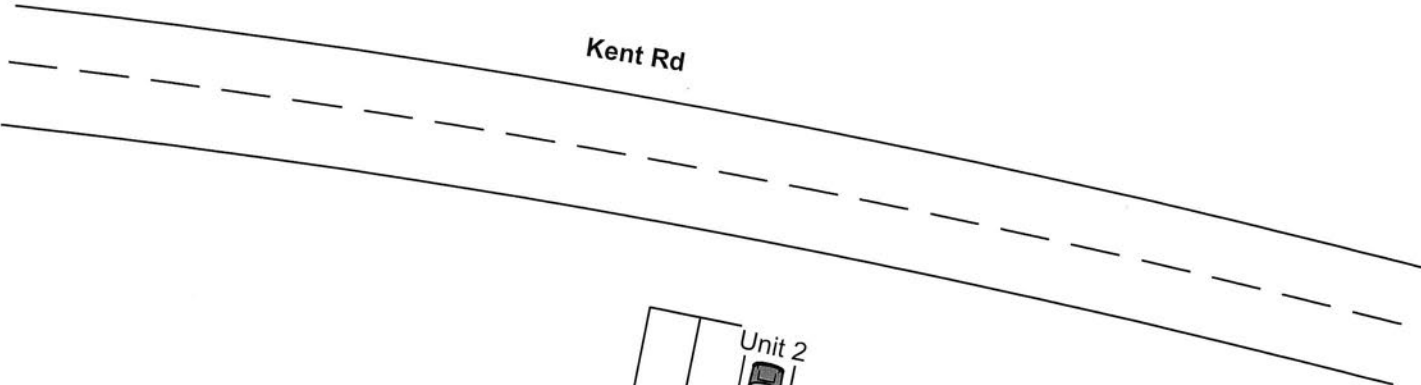

I was backing my car from Chipotle parking lot & other car guy also backing his car from parking lot we both hit our back side of car after that we call 911 & they he came.


