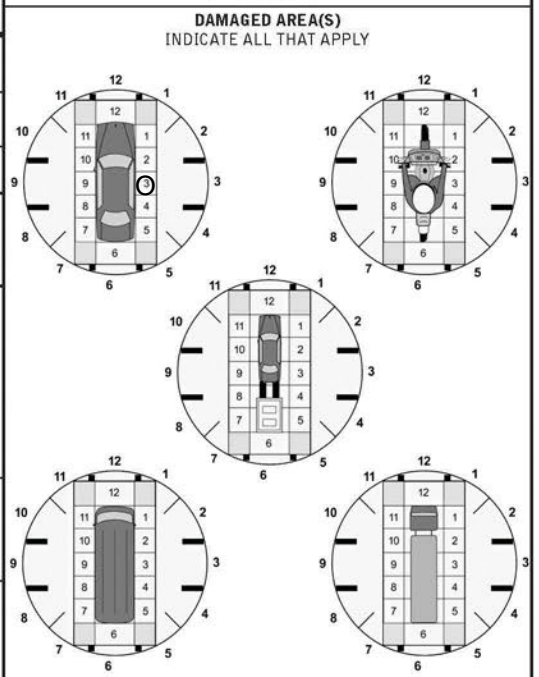

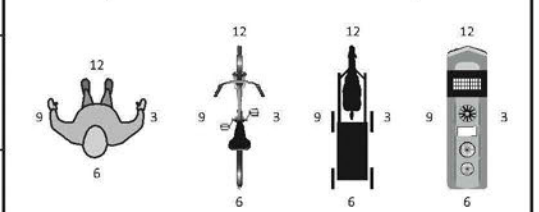

The other car continued going left. I waited for my light to turn green, so I could pull over and ask if he was OK/needed help.
