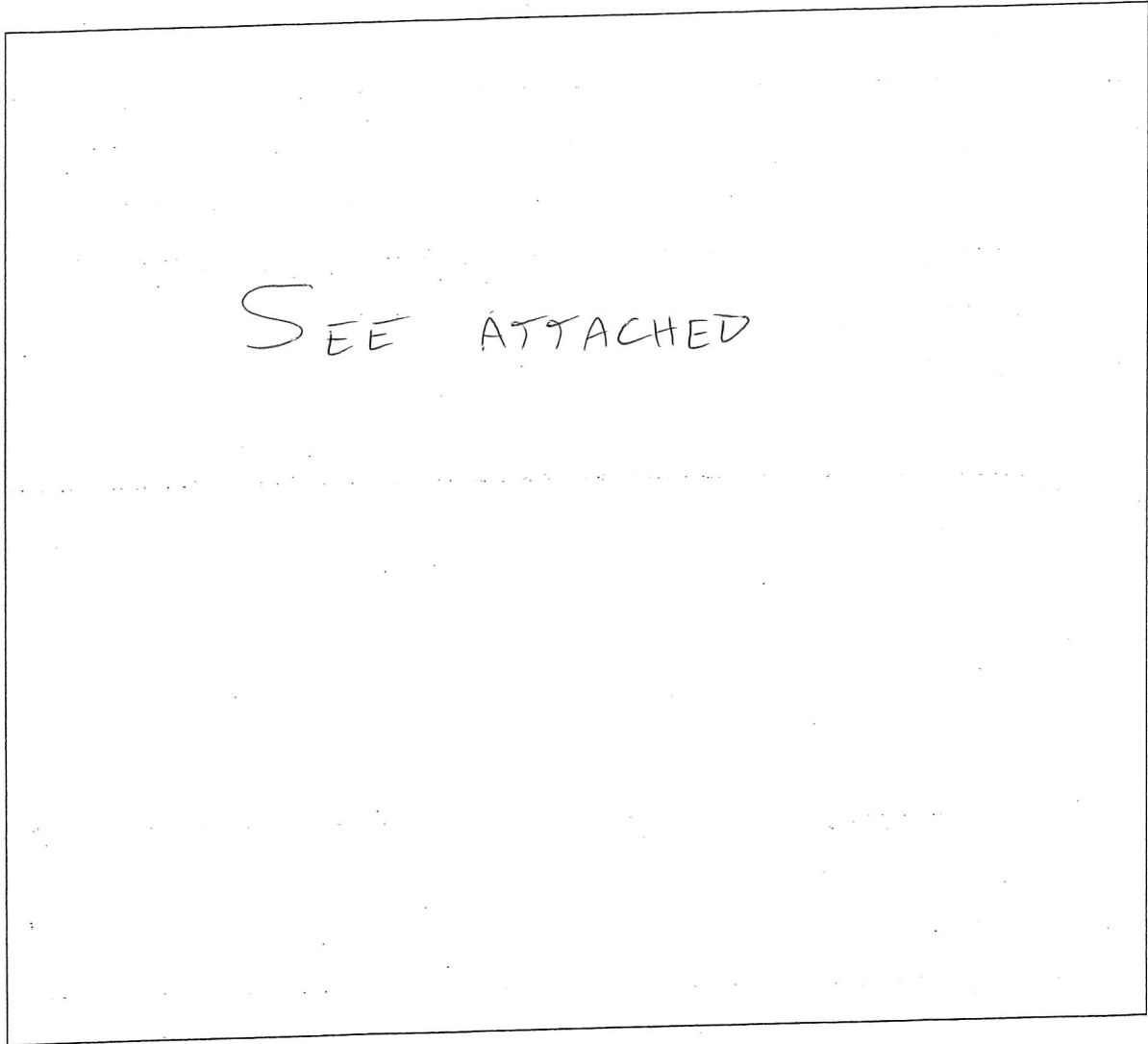

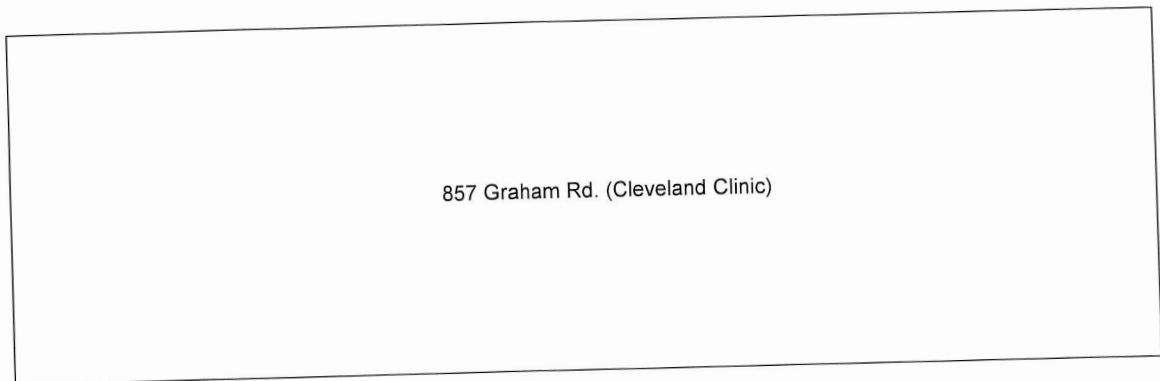

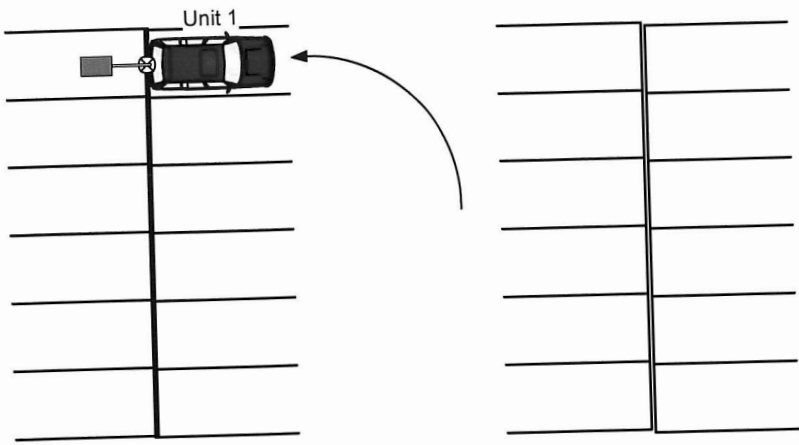

An older gentleman driving a Red GMC Yukon with license plate KHT 7029 backed into a handicap parking spot and ran over the pole. He then struggled between brake and gas while squealing the tires to leave the parking spot to then drive around the parking lot. A woman came over and stood the pole up and the gentleman just sat and watched. He then circled around again and tried to back back into the same spot again, over compensated his turn and hit a silver sedan Chevy LTZ V6 license plate JZR 4820 resulting in a dented side door and a broken window with a damaged side mirror. He displaced the car significantly. He then struggled to leave the parking spot while burning out the tires because, im assuming, he was driving with two feet. I suspect he may have been having a medical emergency or was having a lapse of judgement.
