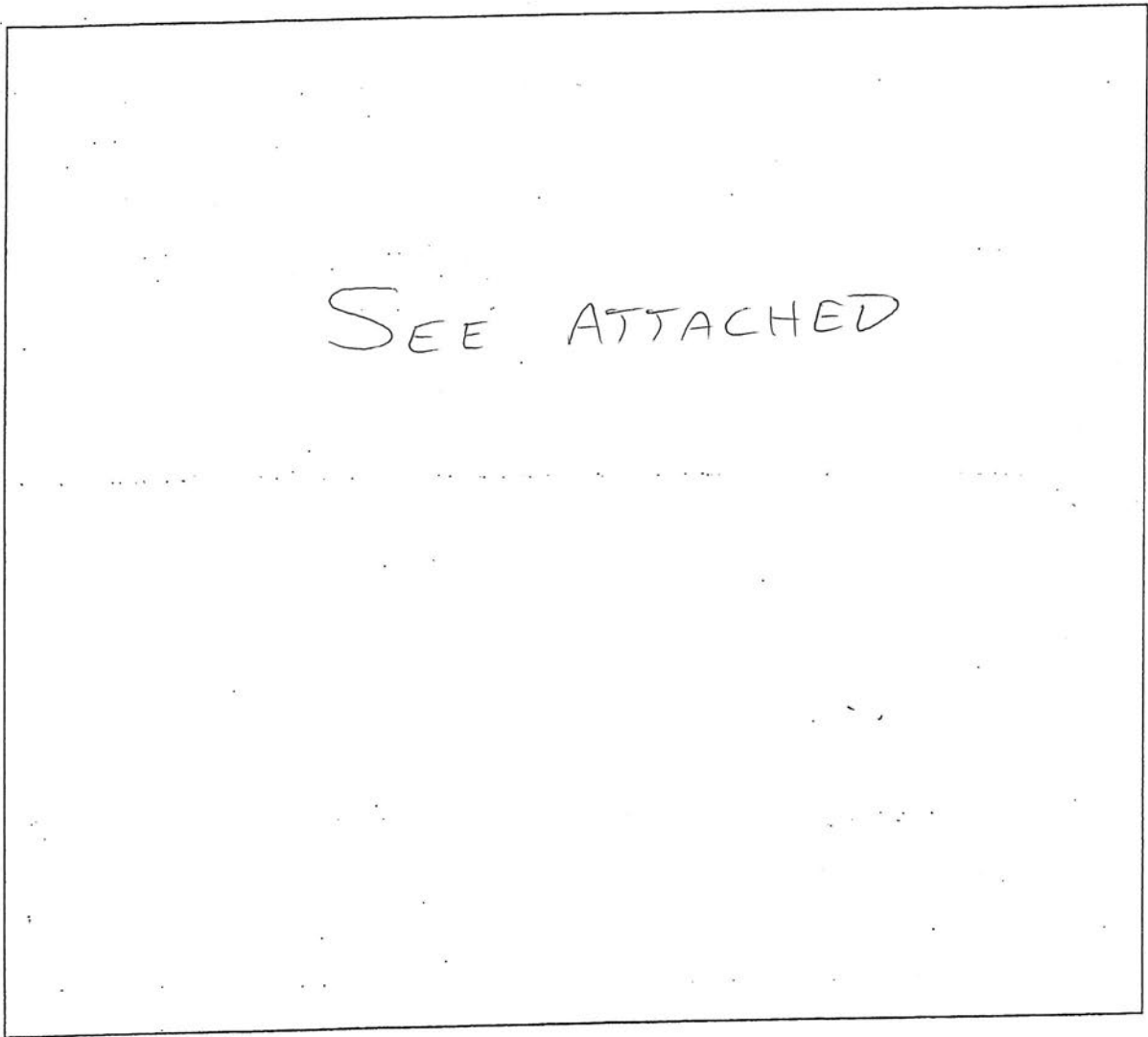

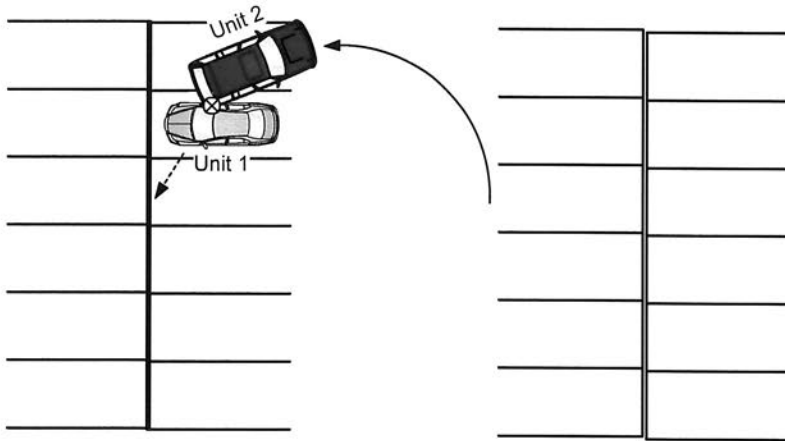
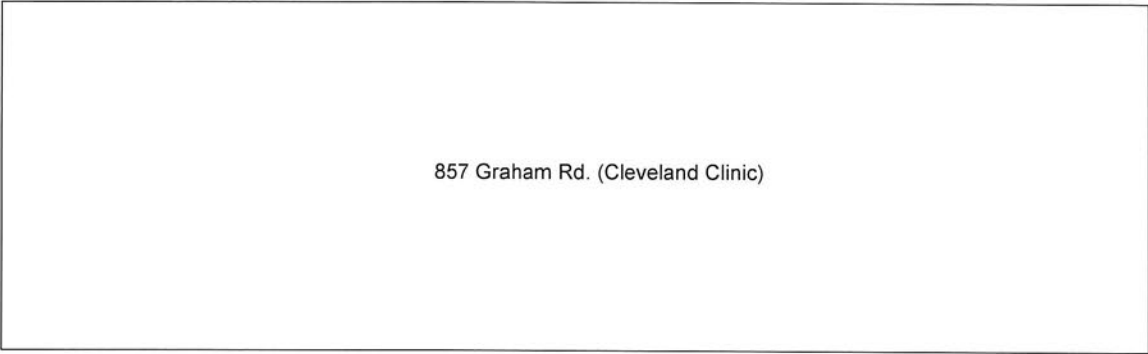

He then circled around again and tried to back back into the same spot again, over compensated his turn and hit a silver sedan Chevy LTZ V6 license plate JZR 4820 resulting in a dented side door and a broken window with a damaged side mirror. He displaced the car significantly. He then struggled to leave the parking spot while burning out the tires because, I'm assuming, he was driving with two feet.
