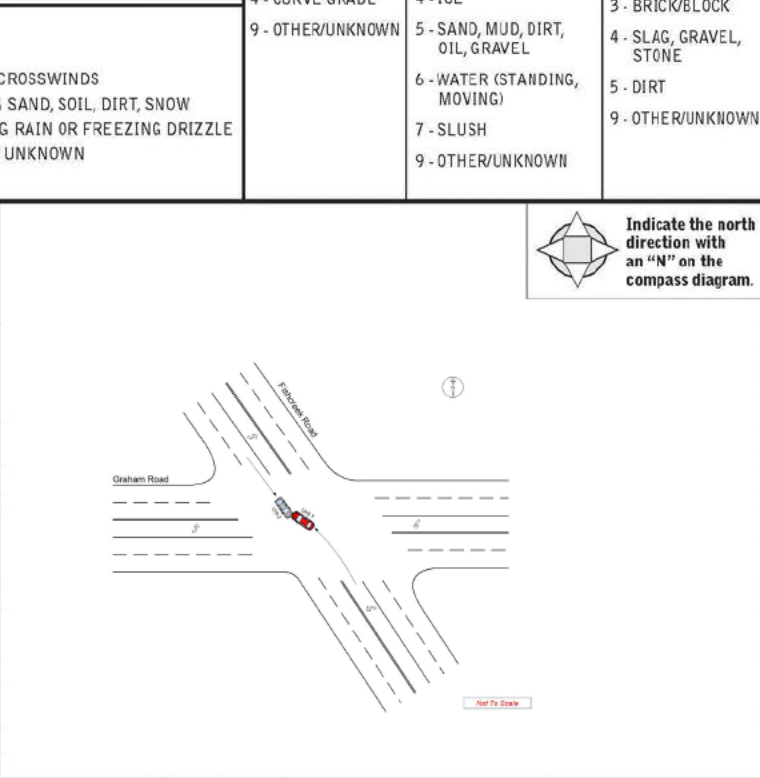

NARRATIVE

Unit 1 was traveling north on Fishcreek Rd. approaching the Graham Rd. intersection. Unit 1 entered the left turn lane and began to make a left turn to travel west on Graham Rd. after observing the green arrow signal. Unit 2 was traveling south on Fishcreek Rd. approaching Graham Rd. As Unit 1 was making the left turn, Unit 2 ran the red signal, traveled into the intersection, and struck Unit 1.

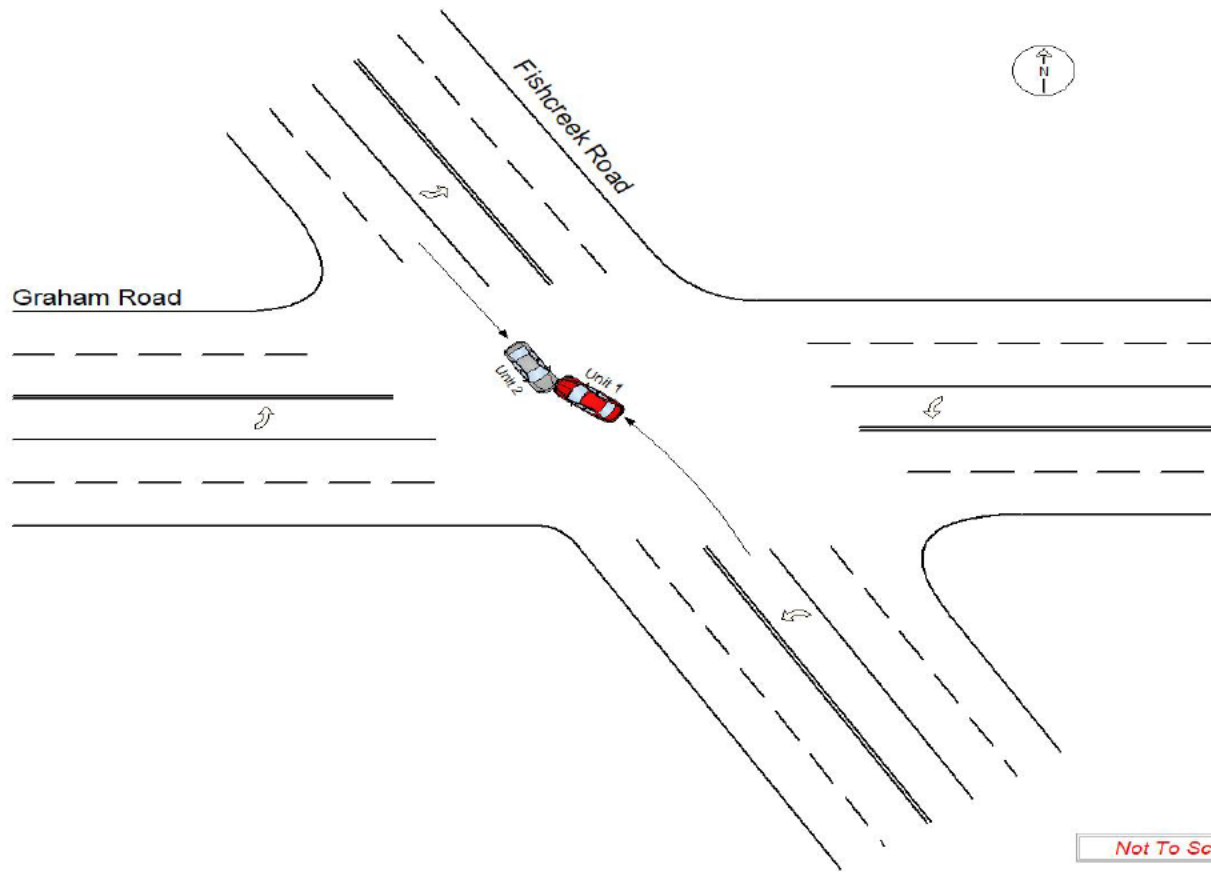
