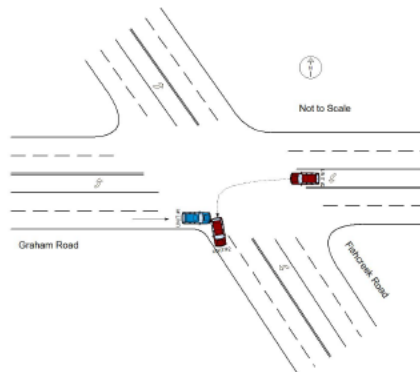
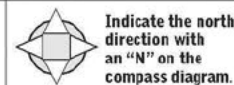

UNIT #1 WAS TRAVELING EASTBOUND ON GRAHAM RD. IN THE RIGHT-LANE APPROACHING FISHCREEK RD. UNIT #2 WAS HEADING WESTBOUND ON GRAHAM RD. AND WAS ATTEMPTING TO MAKE A LEFT-TURN TO HEAD SOUTHBOUND ONTO FISHCREEK RD. UNIT #1 HAD A GREEN TRAFFIC SIGNAL. UNIT #2 FAILED TO YIELD TO THE RIGHT-OF-WAY OF UNIT #1. AS A RESULT, THE FRONT END OF UNIT #1 STRUCK THE REAR PASSENGER SIDE OF UNIT #2.

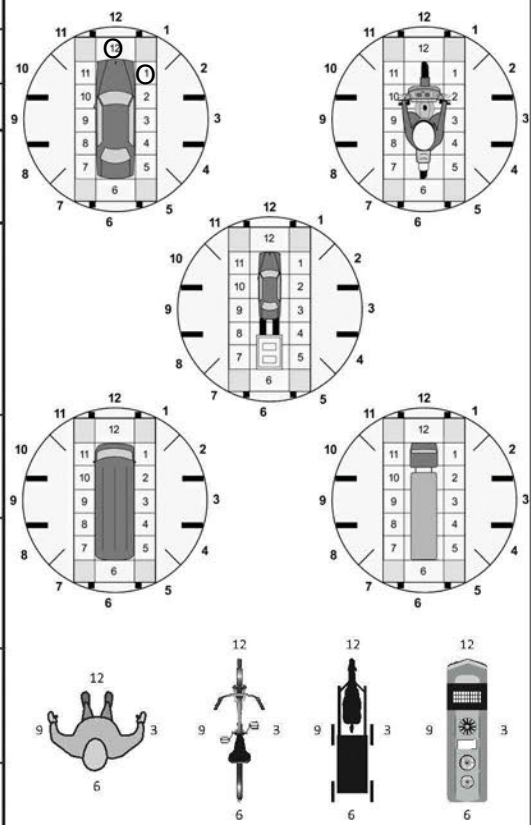

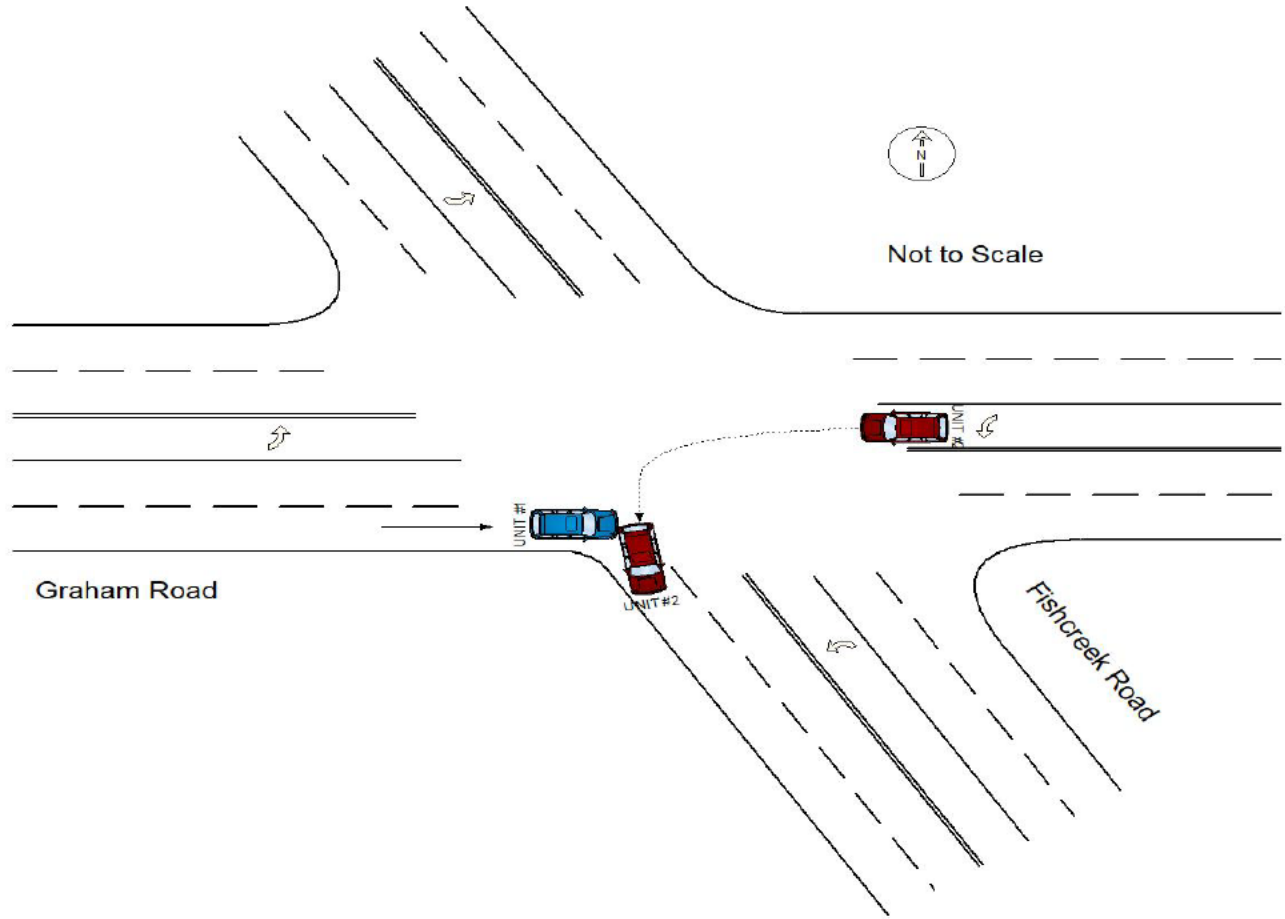
