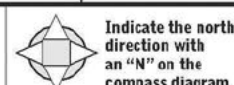

Unit 2 was exiting the private drive of 4145 Kent Rd. from north to south and struck Unit 1 on the passenger side. Unit 1 was towed due to the steering wheel being locked, which appeared to be caused by malfunctioning sensors.
