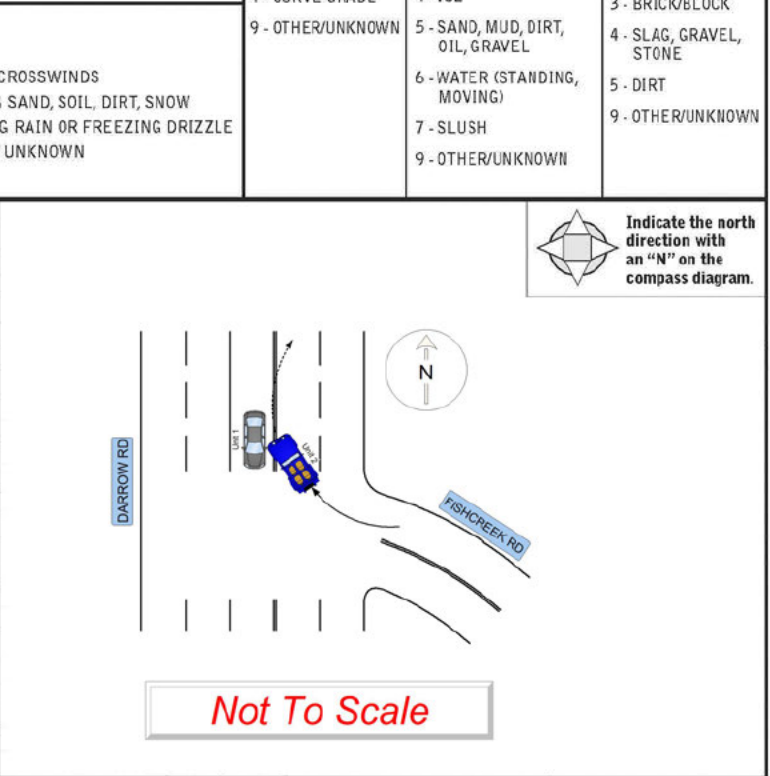

UNIT 2 WAS TRAVELING WESTBOUND ON FISHCREEK ROAD AND MADE AN IMPROPER RIGHT TURN ONTO DARROW ROAD. UNIT 2 STRUCK UNIT 1 IN THE DRIVER SIDE MIRROR, CAUSING MINOR DAMAGE. UNIT 2 LEFT THE SCENE IMMEDIATELY AFTERWARDS.**

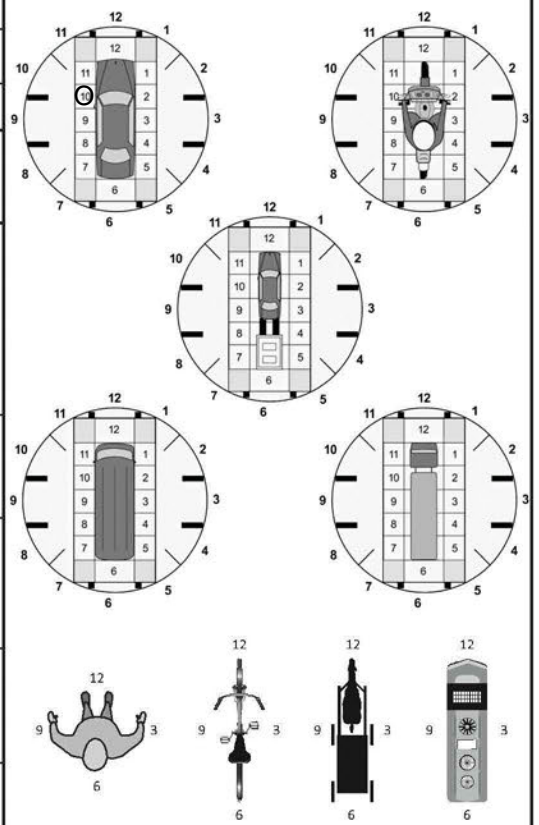

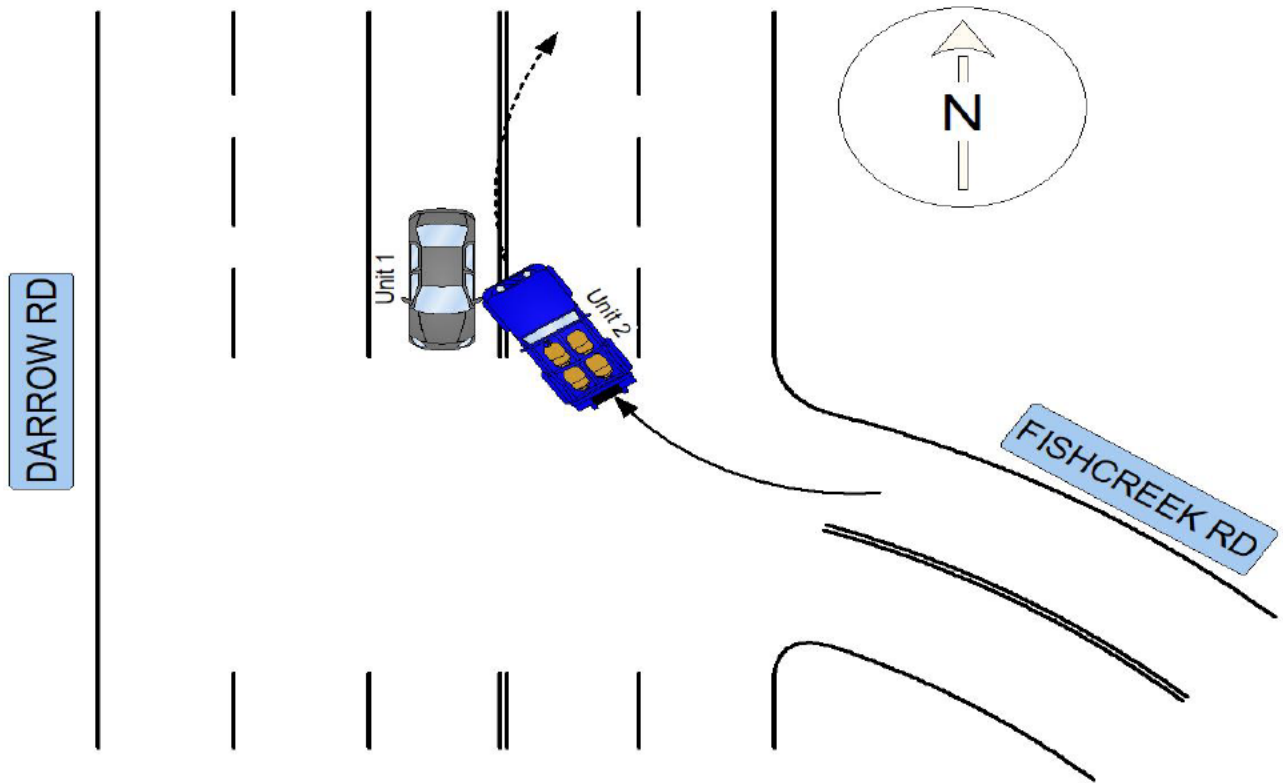
