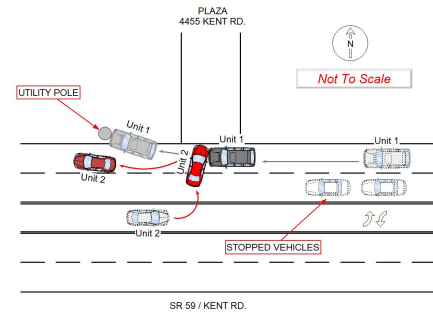

NARRATIVE

Unit #1 was westbound in the curb lane of Kent Rd. (SR 59).
Unit #2 was eastbound on Kent Rd. turning left (north) into the plaza at 4455 Kent Rd. The inside westbound lane stopped to allow unit #2 to turn. Unit #2 failed to yield to traffic in the curb lane and turned in front of unit #1. Unit #1 struck unit #2, then a curb, and came to rest against a utility pole. Unit #2 was spun around by the collision.
Unit #1 = Erie Insurance, unknown policy number.
