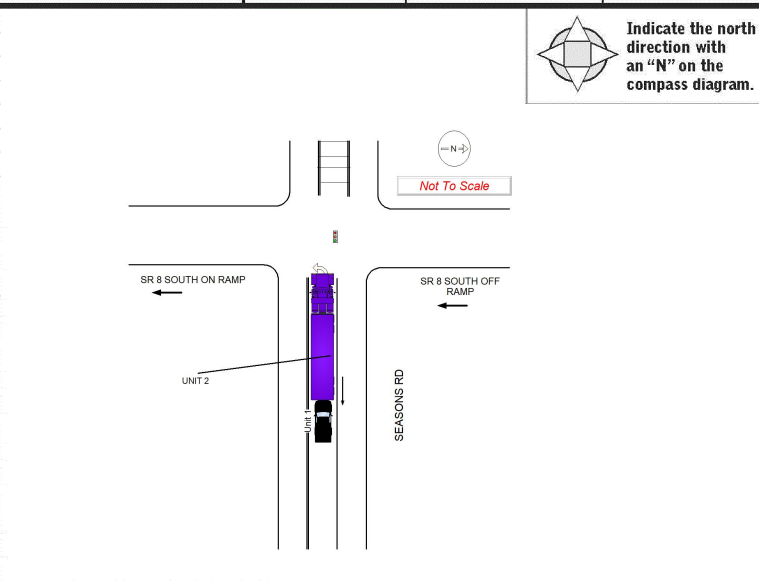

NARRATIVE
Unit 1 and unit 2 were stopped facing westbound at the stop light on Seasons Rd. right before the SR. 8 South entrance. Unit 2 was in front of unit 1 at the stop light, when the light turned green unit 2 rolled back into unit 1 because of the manual transmission being let out, and the stop light being on a slight hill. This caused unit 2 to hit unit 1 causing minor damage to unit 1.
