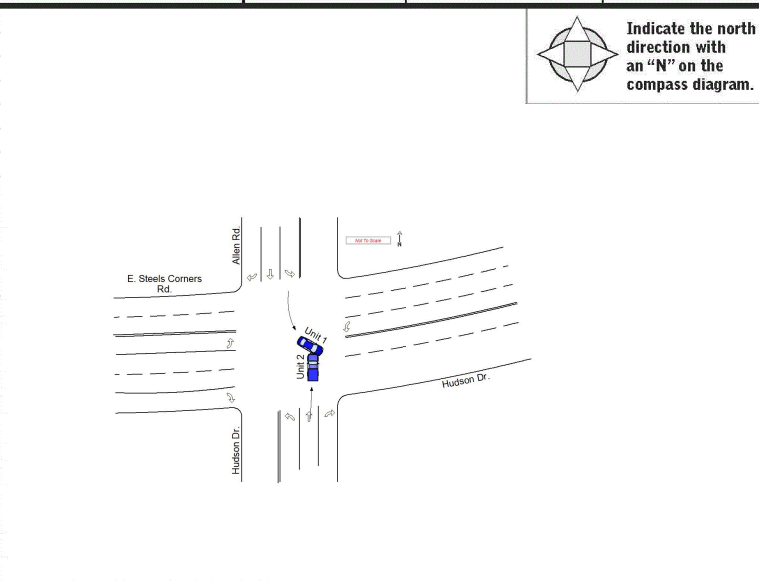

Unit 1 was southbound on Allen Rd. attempting to make a turn to head northbound on Hudson Dr. Unit 1 failed to yield the right of way to Unit 2, turning in front of them, causing Unit 2 to strike Unit 1.

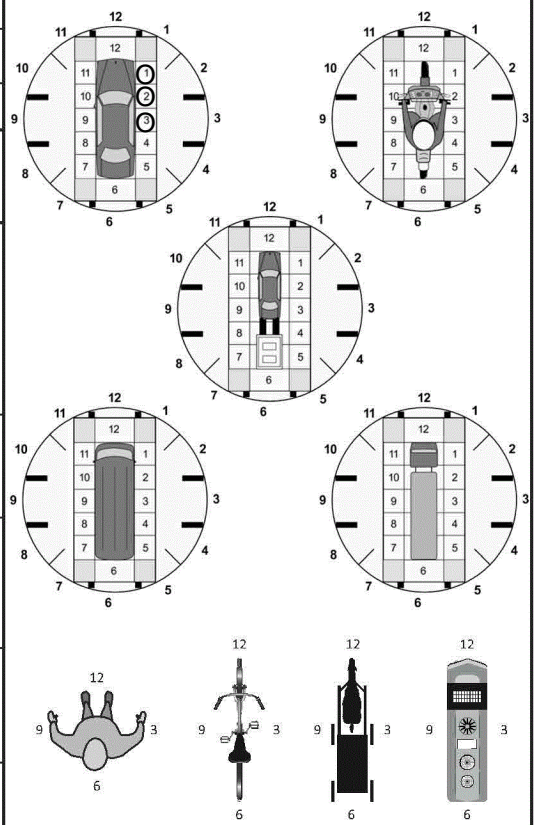
