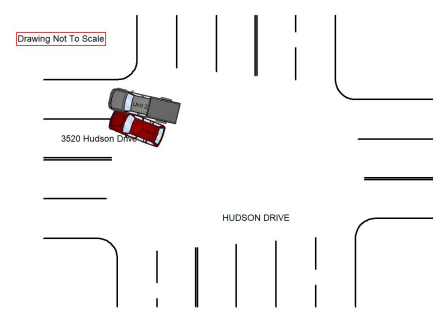

There was light damage to both vehicles.

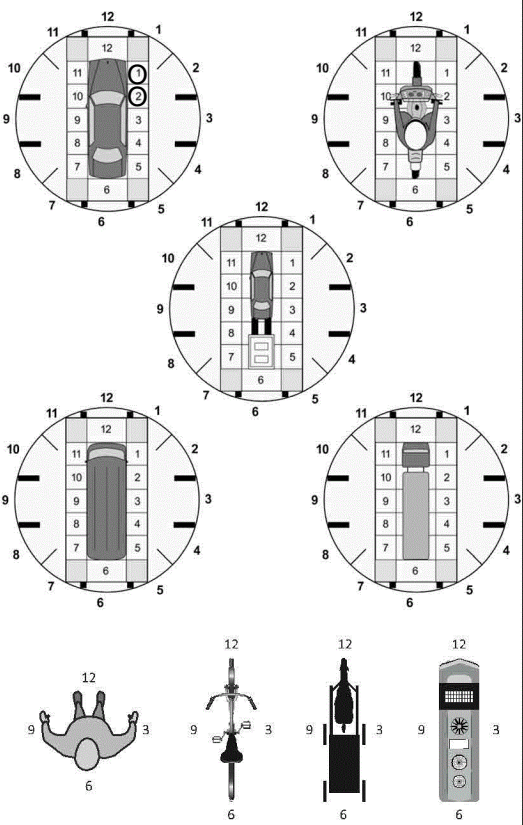

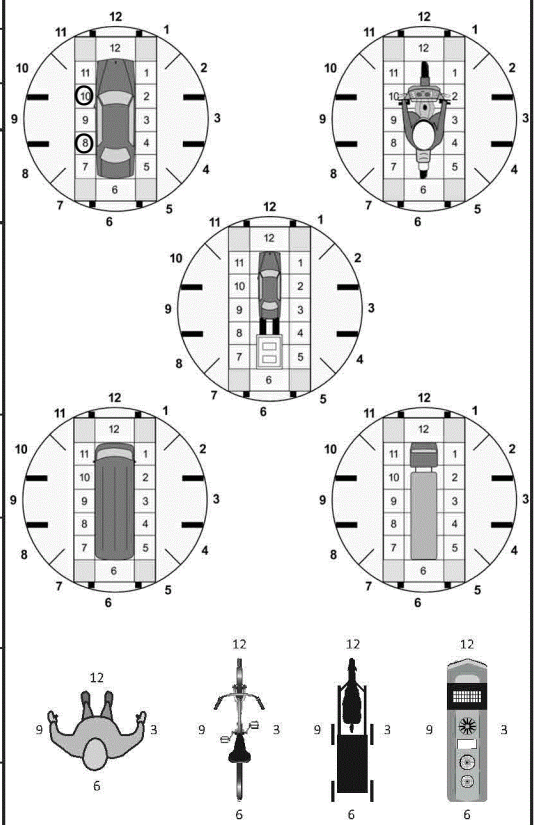
