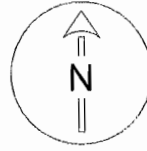
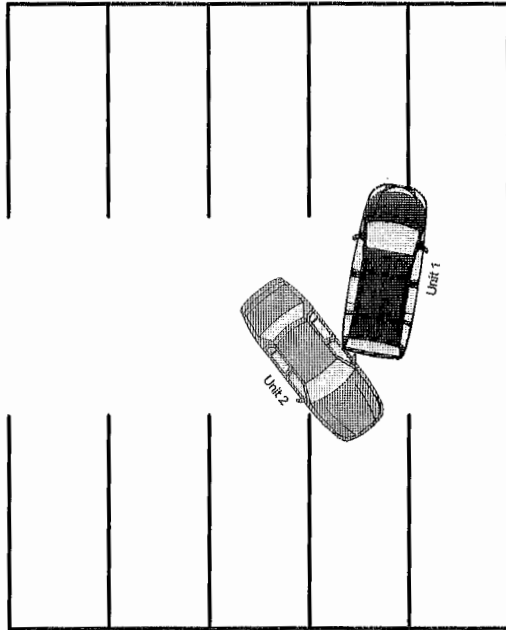
DESCRIBE WHAT HAPPENED
