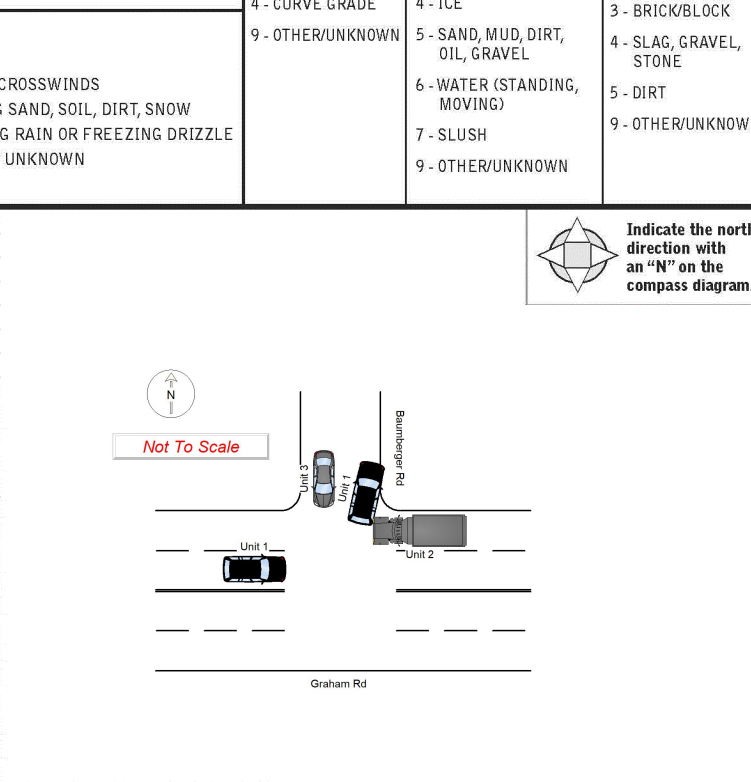

**Unit 01 was eastbound on Graham Road, waiting to turn left at the intersection of Baumberger Rd. Unit 02, a dump truck, was westbound on Graham Road approaching the intersection of Baumberger Rd. Unit 03 was southbound on Baumberger Rd stopped at a red light for the intersection of Graham Rd. Ultimately, Unit 01 failed to yield the right of way for Unit 02, which caused Unit 02 to strike Unit 01. The debris from this collision was set in motion and caused minor, superficial damage to Unit 03.**


