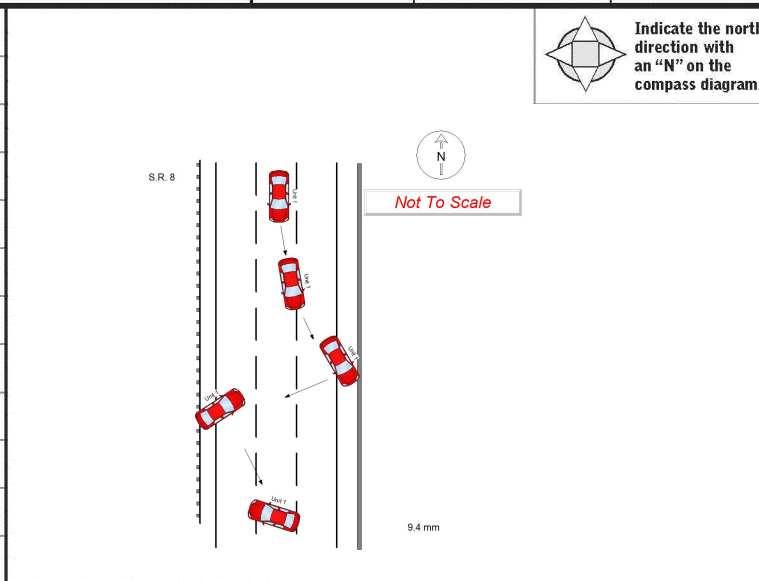

Unit 1 was traveling southbound on S.R. 8 near the 9.4-mile post. Unit 1 was in the middle lane. Unit 1 went to change lanes to the right lane and almost struck a vehicle in that lane. Unit 1 swerved to the left and lost control of its vehicle, striking the concrete barrier and then the guardrail.
