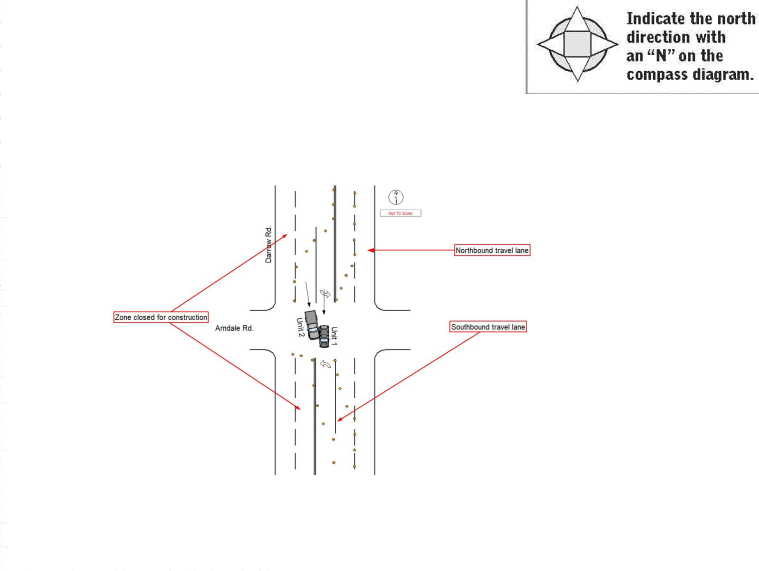

NARRATIVE  
**Units 1 and 2 were traveling southbound on Darrow Rd, in the active construction zone, approaching the intersection with Arndale Rd. Unit 2 was in front of Unit 1 and was going around the turning lane to continue southbound. Unit 1 attempted to pass Unit 2 going through the left turn lane. Unit 2 was merging back into their lane, as other traffic has done, and struck Unit 1 on the rear passenger side of their car. The driver of Unit 1 admitted that the driver of Unit 2 did not have a turn signal on and was simply trying to pass them because they did not want to be behind them anymore.**

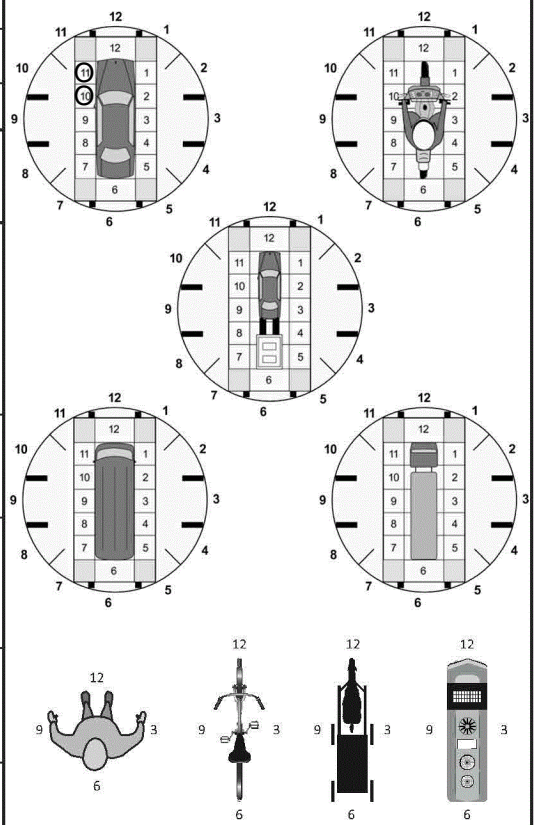
