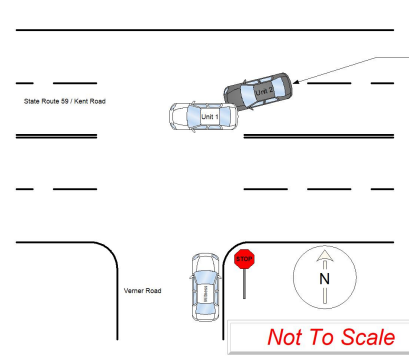
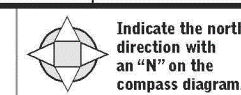

NARRATIVE

Unit 1 was stopped in traffic, while W/B on SR59/Kent Rd, waiting to turn left (S/B) on Verner Rd. Unit 2 was also W/B on SR59/Kent Rd. The driver of Unit 2 stated he changed lanes from the right lane into the left lane, failed to maintain an assured clear distance ahead, and struck Unit 1 in the rear.

*Unit 1 stated he didn't have functional airbags due to another recent deer crash. He also stated he was wearing his seatbelt, but struck his forehead as if he were not restrained.
