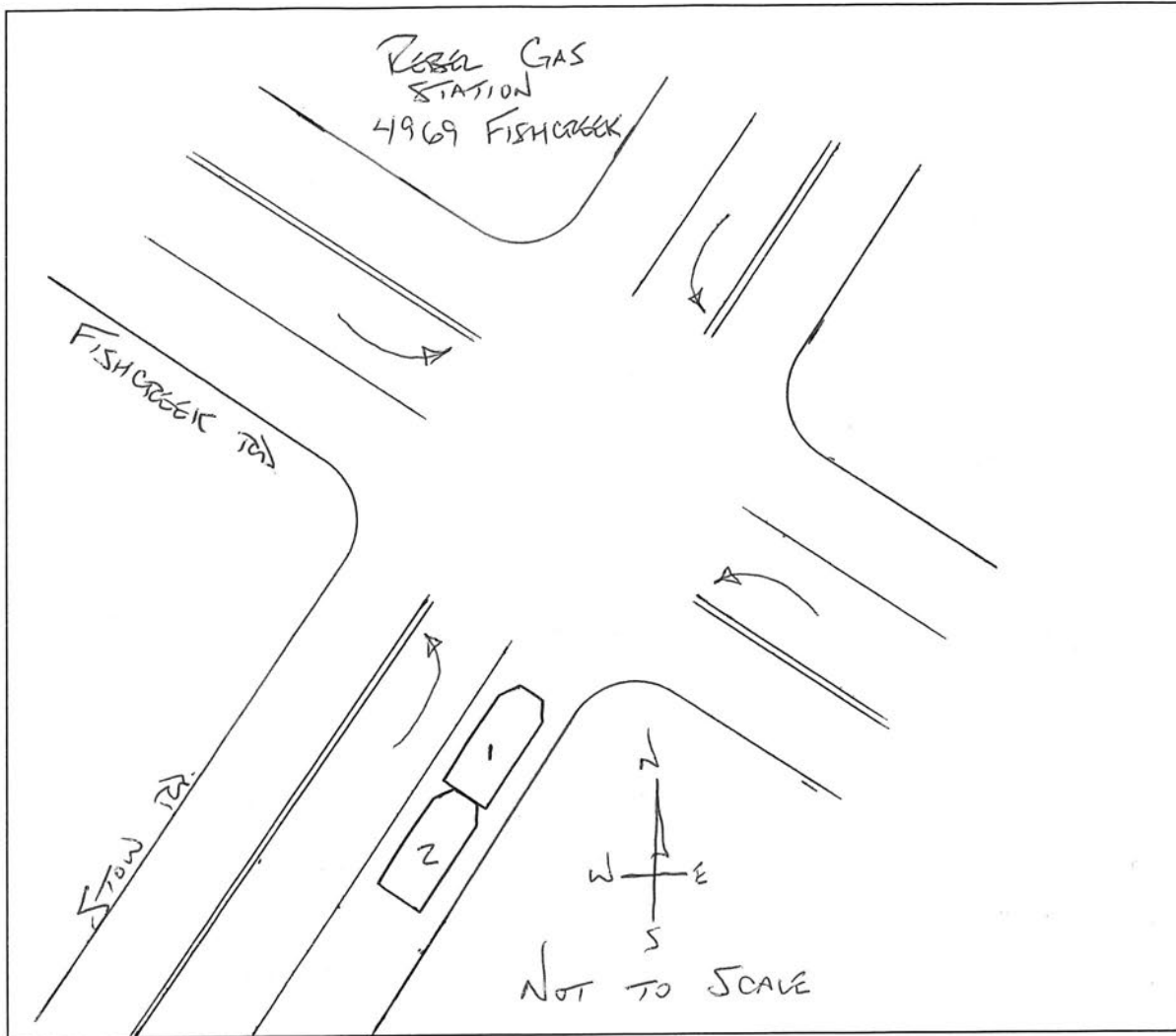
DESCRIBE WHAT HAPPENED
