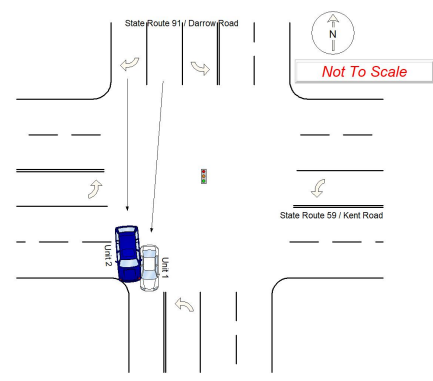

**Unit 1 was S/B on SR91 (Darrow Rd), in the only lane to continue straight. Unit 2 was also S/B on SR91, but in the right-turn-only lane. As they were both going straight through the intersection at SR59 (Kent Rd), Unit 2 improperly merged into the straight lane (instead of turning right) and collided with Unit 1.**

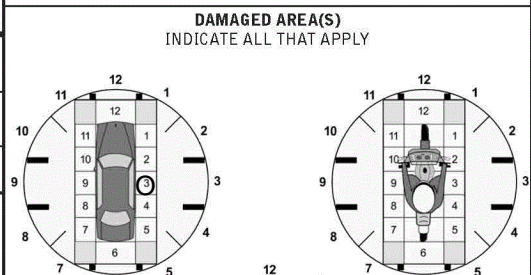

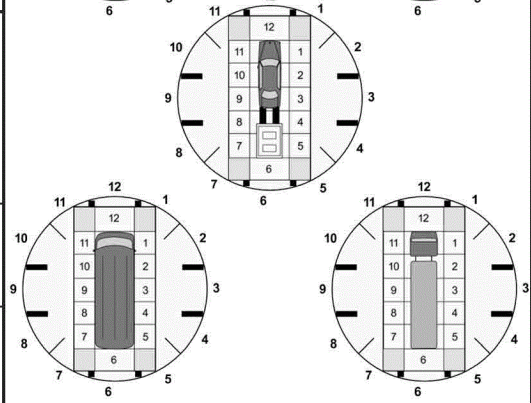

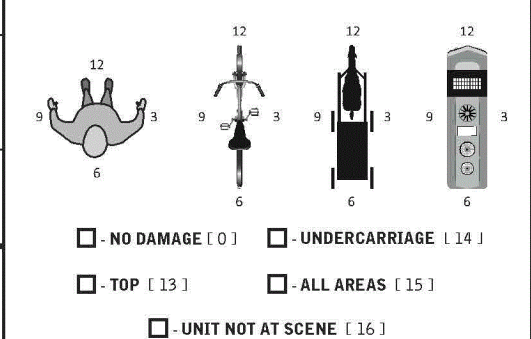
