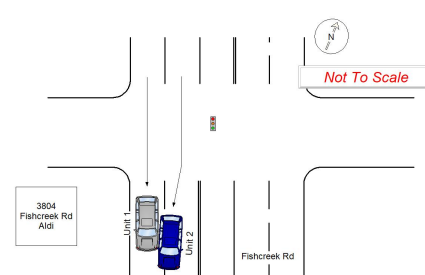
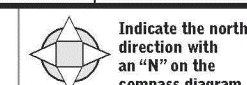
Unit 1 was s/b on Fishcreek Rd, in the right/curb lane.

Unit 2 was also s/b on Fishcreek Rd, in the left lane.

Unit 2 improperly merged into the right lane and struck Unit 1. Unit 1 honked and attempted to get Unit 2 to stop.

Unit 1 obtained the license plate of Unit 2 as it turned right (w/b) onto SR59/Kent Rd, and pulled in and out of the Dick's Sporting Goods parking lot (4399 Kent Rd).

Unit 1 followed Dispatch advice and stopped following Unit 2 as it fled w/b on SR59, but the driver of Unit 2 was cited shortly thereafter.

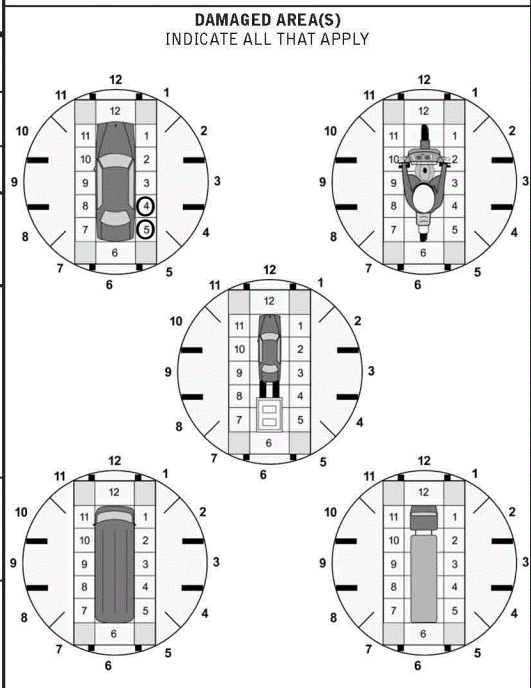
