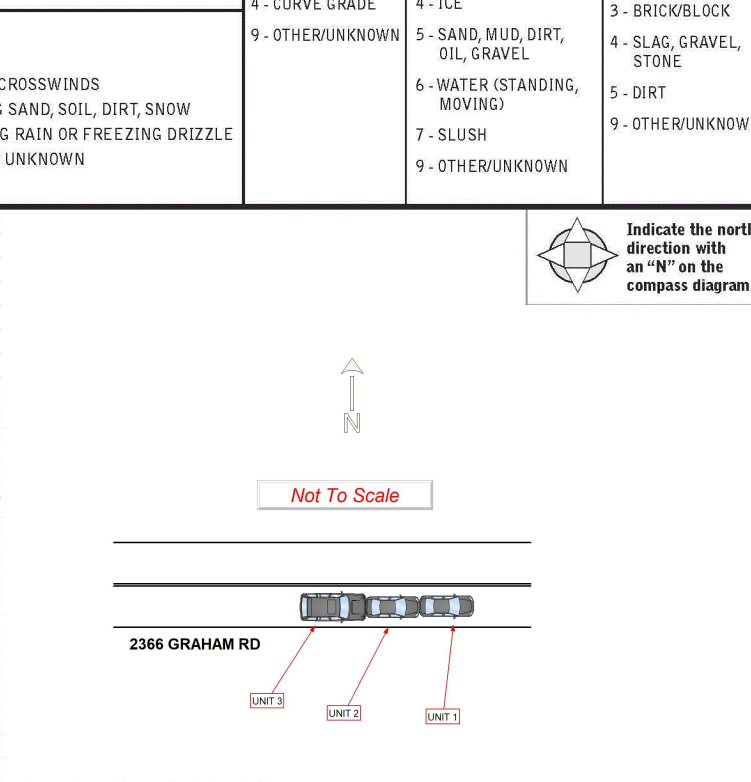

Unit 3 was following too closely behind Unit 2, failed to assure clear distance, and struck Unit 2 in the rear of the vehicle. Unit 2 then struck Unit 1 as a result of being struck by Unit 3.
