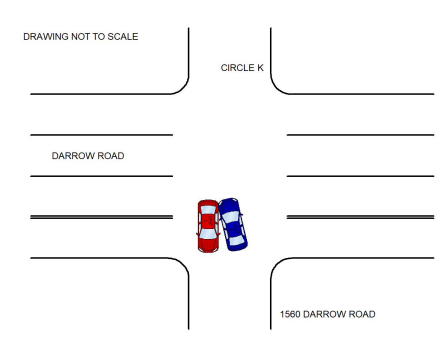
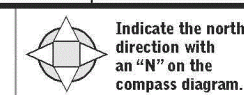

NARRATIVE

Unit-1 was exiting Circle K in Hudson s/b into Towne Centre Plaza, between Burger King and Arby's. As unit-1 crossed over, unit-2 exited Towne Centre n/b and turned left, w/b, onto Norton Road towards Darrow Road. The driver of unit-1 observed unit-2 as a dark blue sedan, but did not notice a detailed description otherwise. Unit-1 did not see Unit-2 coming across and was looking left and right, more concerned about getting hit by cross traffic. Unit-2 failed to give the right of way to unit-1 while making a left turn. After striking unit-1, unit-2 did not stop and fled the area, and could not be identified as of

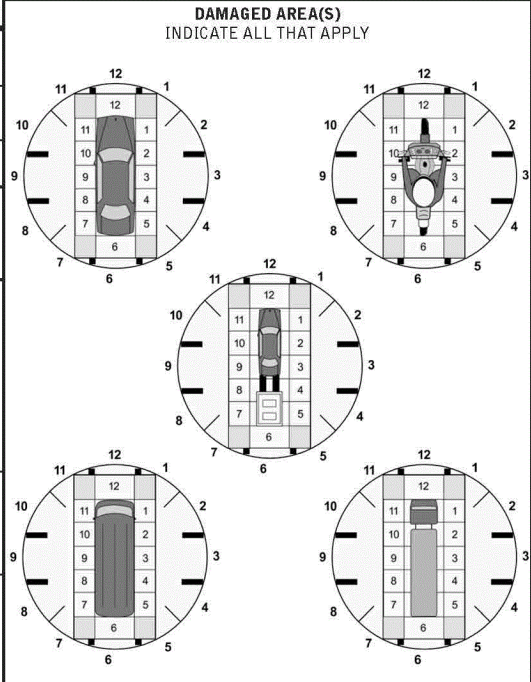

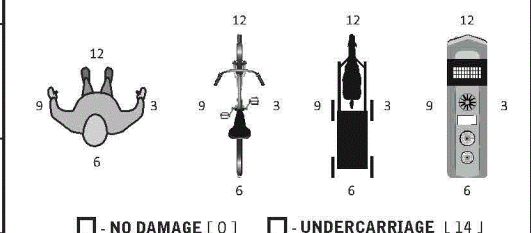
