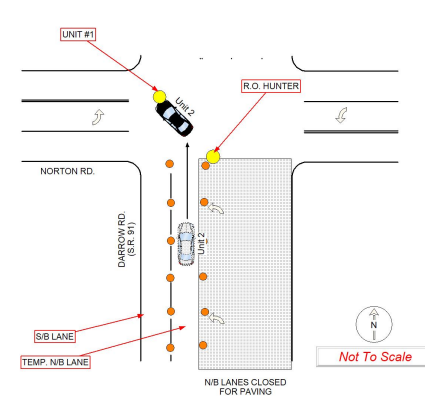
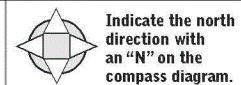

Unit #1 was a construction worker in the intersection of Darrow and Norton Rd. Unit #2 was northbound on Darrow Rd. attempting to turn left (west) onto Norton Rd. Stow Reserve Officer Hunter was directing traffic at the intersection. Traffic was being directed to continue straight (north and south) through the intersection. East or west turns were temporarily suspended due to the construction zone. Unit #2 proceeded to turn left and struck unit #1.

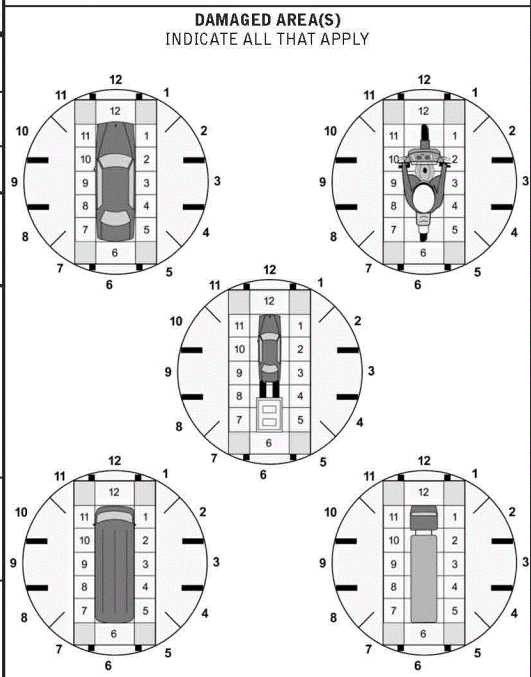

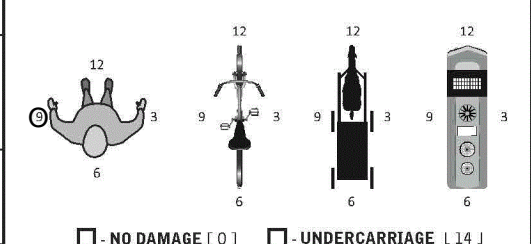

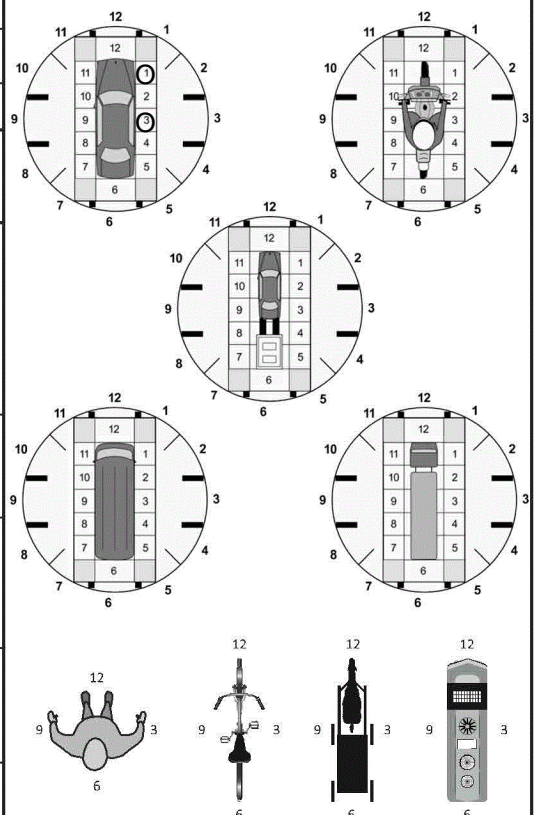
