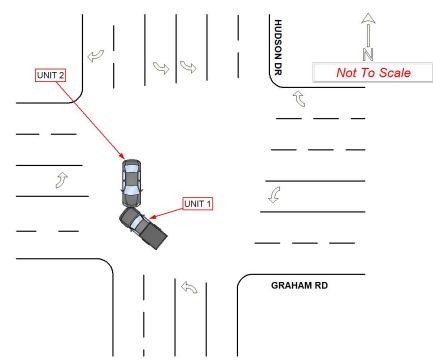

NARRATIVE
Unit 1 was traveling Northbound on Hudson Drive in the left turn lane and was yielding in the intersection to make a left turn onto Graham Road. Unit 2 was traveling southbound on Hudson Drive and traveling straight from the right-turn-only lane. Unit 2 ran a red light and struck Unit 1 in the intersection while Unit 1 was yielding, attempting to complete a left turn. As a result, the front bumper of Unit 2 had disabling damage, and the front right bumper of Unit 1 had disabling damage. Both cars were towed from the scene.

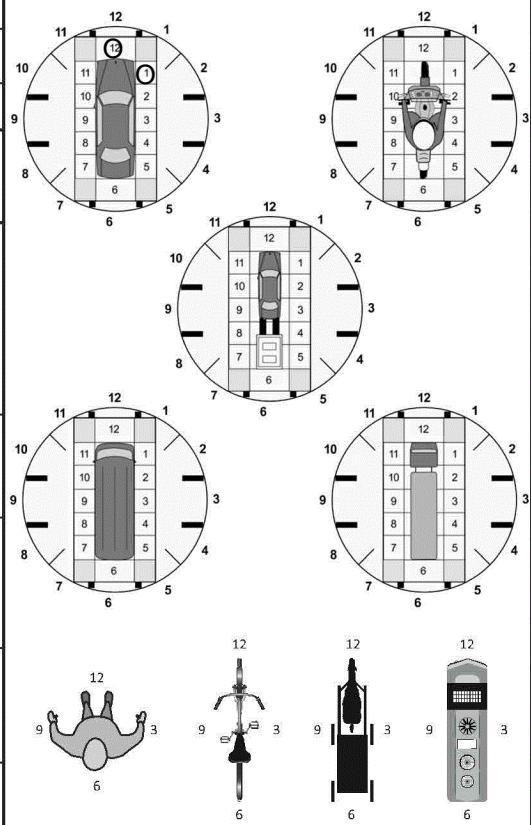
