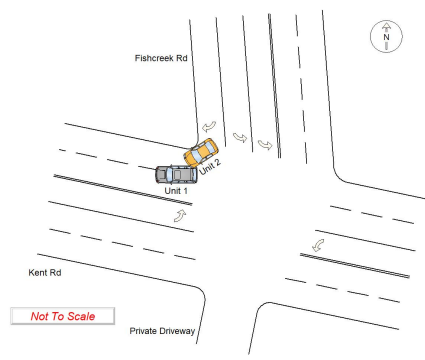

Unit 1 was westbound on Kent Rd in the curbside lane. Unit 2 was southbound on Fishcreek Rd in the right curbside lane. As Unit 1 crossed the intersection westbound, Unit 2 turned right into the curbside lane of Kent Rd. Unit 1 attempted to swerve into the other lane to avoid Unit 2, but was unable to avoid being struck.

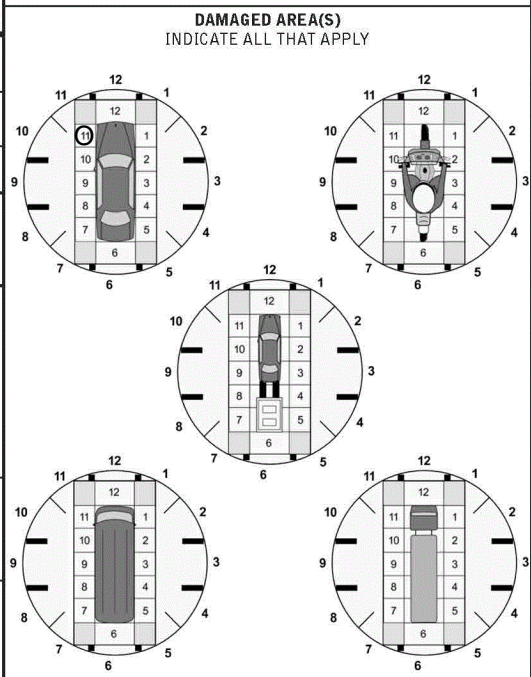

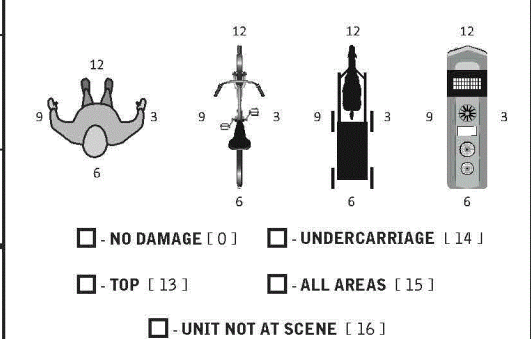
