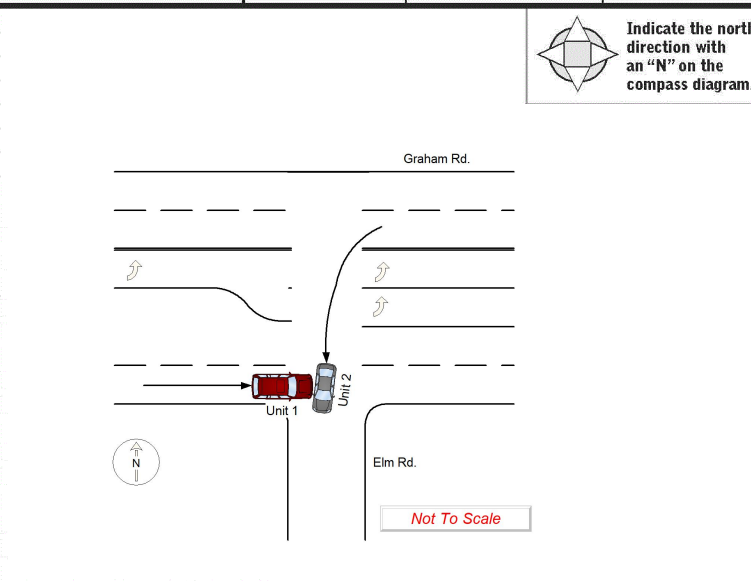

Unit 1 was traveling eastbound in the curbside lane on Graham Rd. Unit 2 was traveling westbound in the inside lane on Graham Rd. Unit 2 was attempting to turn left onto Elm Rd. from Graham Rd. Unit 2, believing traffic to be stopped in the inside lane and clear on the curb side lane, initiated a left turn. Unit 1 struck Unit 2 as it entered the eastbound curbside lane.
