UNIT 2 BEGAN BACKING OUT OF THEIR PARKING SPACE FROM SOUTH TO NORTH AND STRUCK UNIT 1 ON THE REAR DRIVER SIDE REAR.

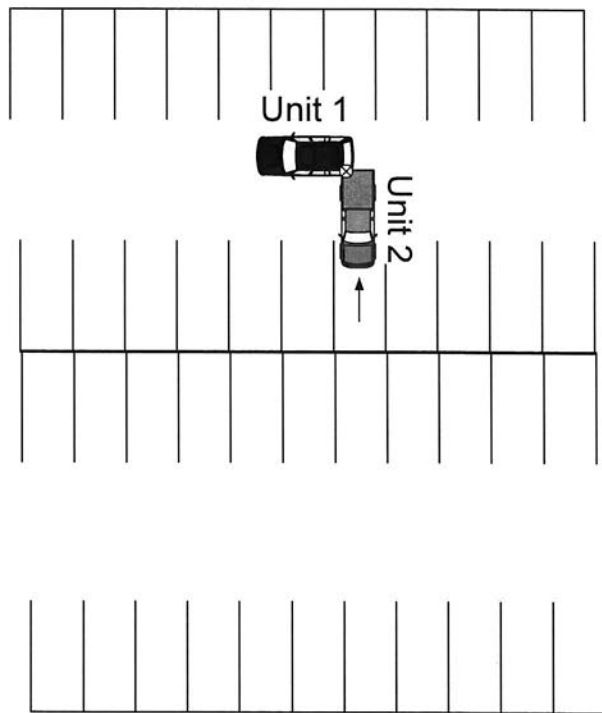
