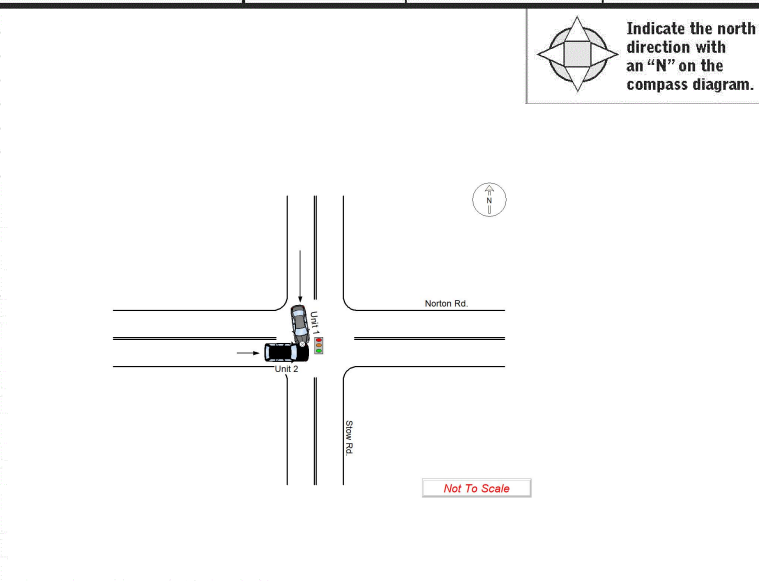

**Unit 1 was traveling south on Stow Rd. approaching the Norton Rd. intersection. Unit 2 was traveling east on Norton Rd. approaching the Stow Rd. intersection. Unit 2 entered the intersection just before Unit 1. Unit 1 struck Unit 2 on the driver's side. Unit 1 and Unit 2 both thought they had the green signal. The two witnesses confirmed Unit 1 had the right of way and that Unit 2 was at fault.**
