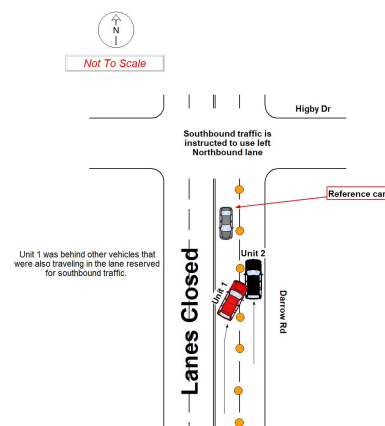
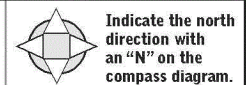

NARRATIVE
The number of through lanes was reduced due to ongoing construction in the area. Unit 1 was traveling northbound on Darrow Rd near Higby Dr in the oncoming traffic lane. Unit 2 was also traveling northbound in the same area but was in the correct lane. Unit 1 then merged right after seeing oncoming traffic and failed to ensure it was safe to do so. Unit 1 struck Unit 2 at an angle and Unit 2 then bumped into the curb. Witness footage was observed and recorded on body worn camera.

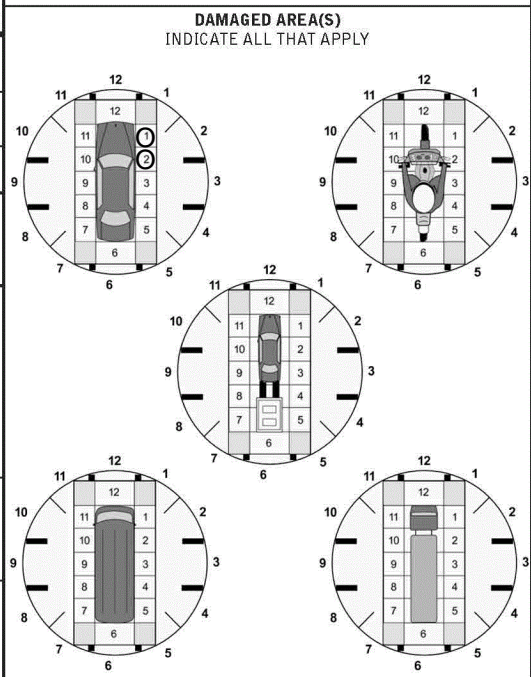

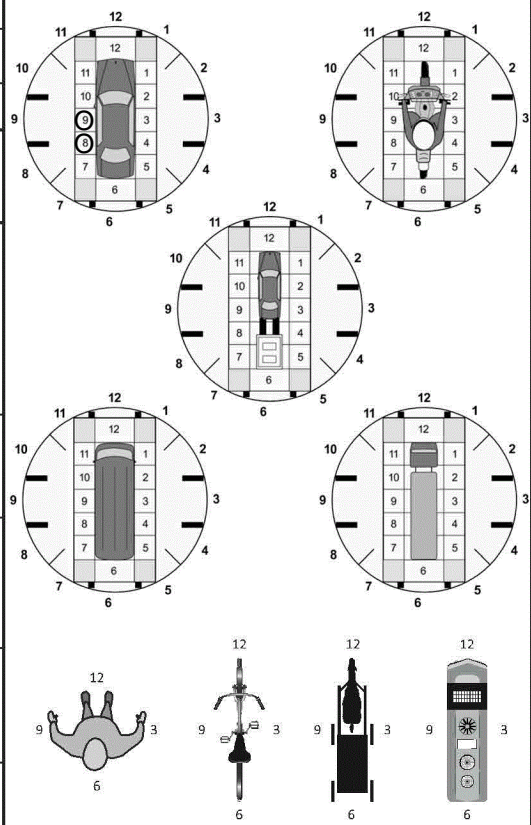

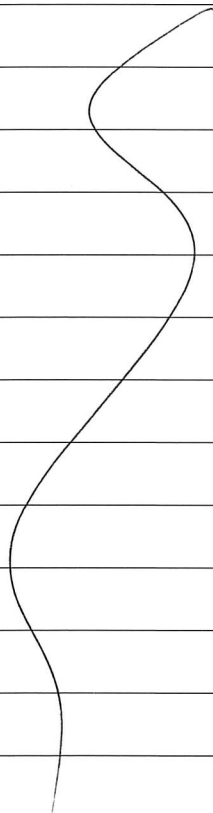
