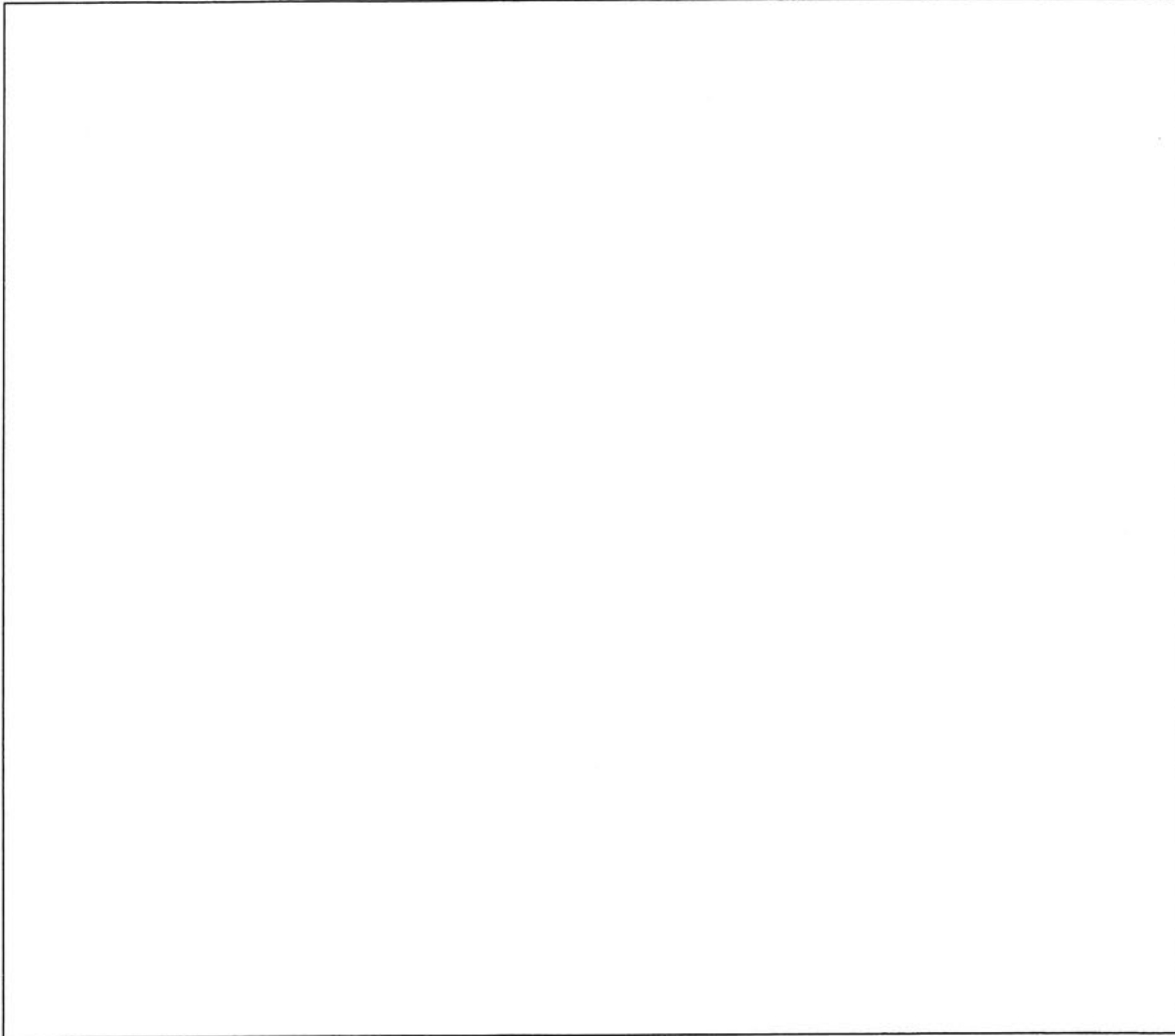

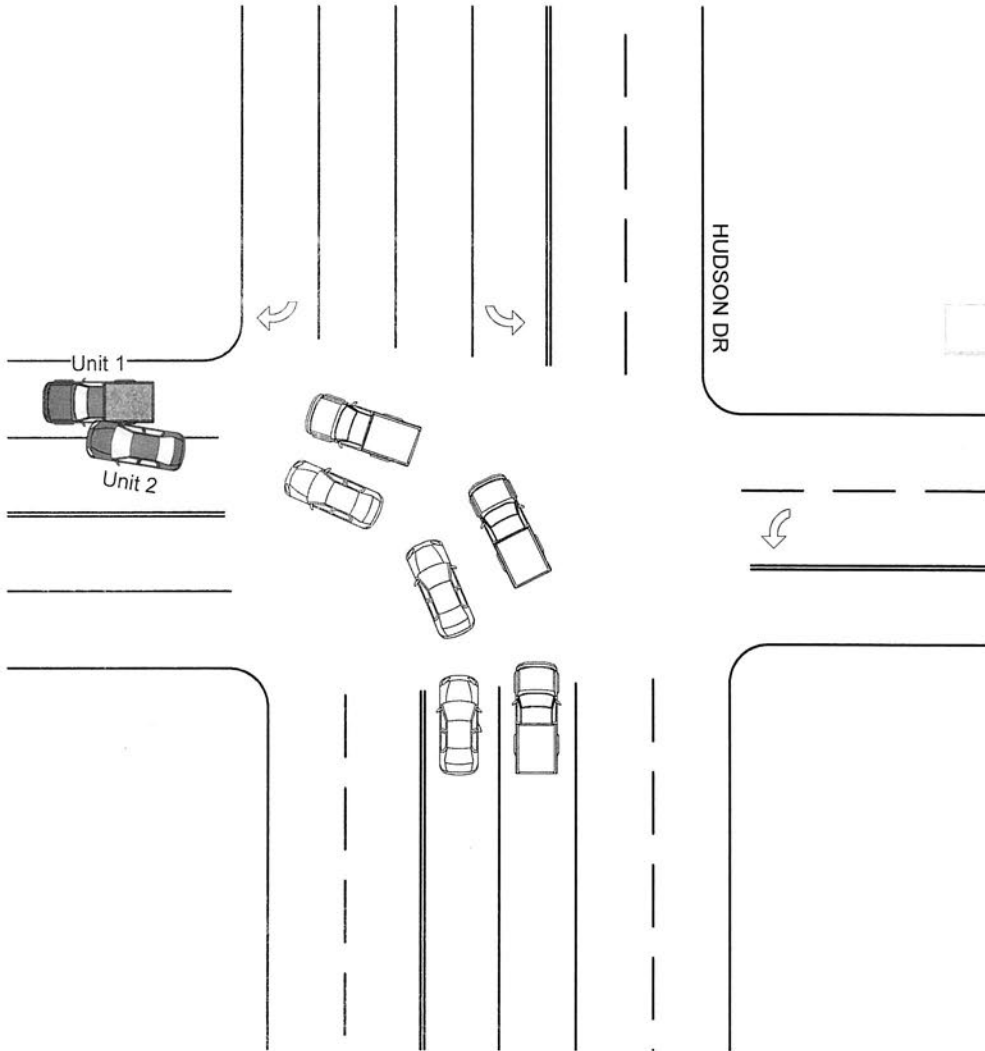

the plaza off of Hudson Drive in Stow, OH, I was in the far right lane and the white Honda merged into my lane, hitting the driver's side back door & runner step.
