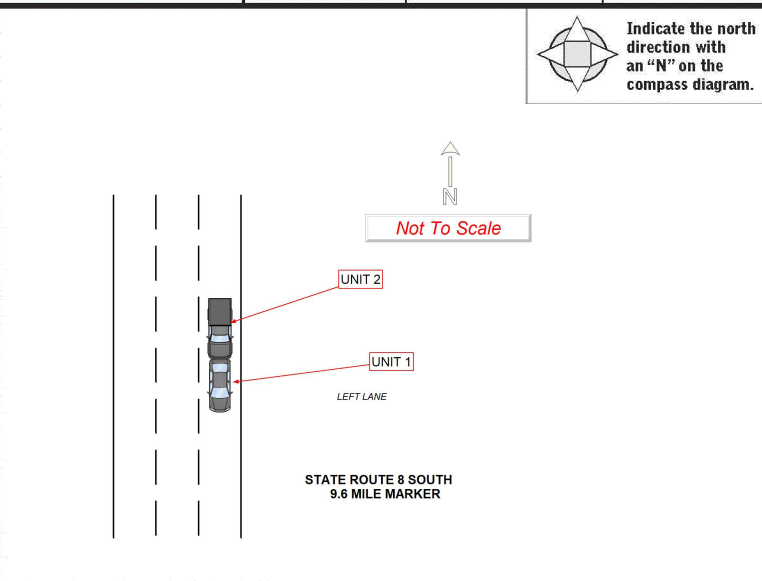

NARRATIVE

Unit 1 was traveling southbound in the center lane on State Route 8, approaching mile marker 9.6. Unit 2 was traveling in the left lane heading the same direction, approaching mile marker 9.6. While Unit 2 was traveling in the left lane, Unit 1 changed lanes into the left lane in front of Unit 2. Both Units continued traveling south in the left lane for a short time, then Unit 2 began flashing its high beams at Unit 1. Unit 2 was following too closely to Unit 1. Unit 1 initiated its breaks and as a result, Unit 1's rear bumper was struck by Unit 2's front bumper.

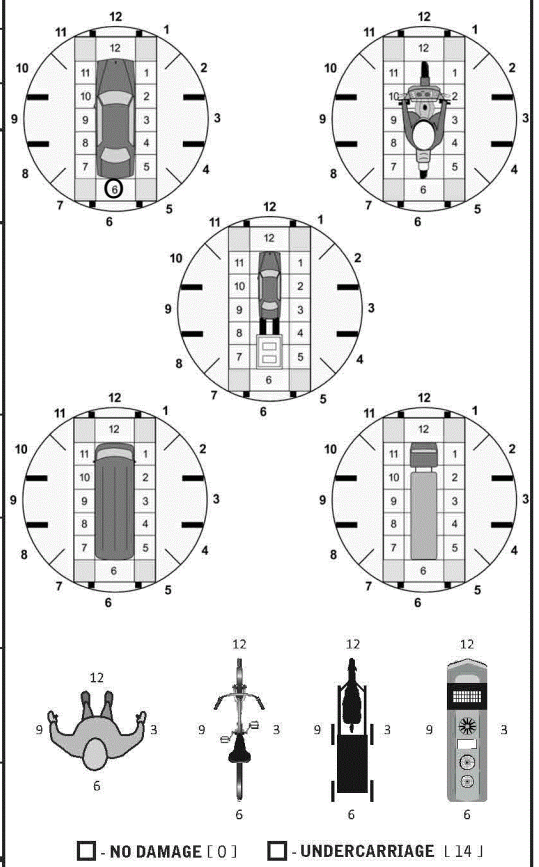
