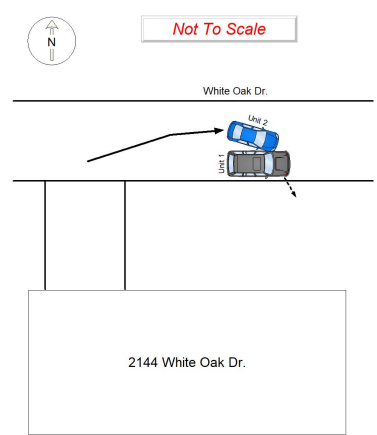

Unit 1 was parked on White Oak Dr., facing eastbound, in front of 2144 White Oak Dr. Unit 2 was traveling eastbound on White Oak Dr. Unit 2 changed into the westbound lane to maneuver around Unit 1. As Unit 2 was changing back into the eastbound lane to avoid oncoming traffic, it struck Unit 1, causing Unit 1 to be pushed off the right side of the roadway.

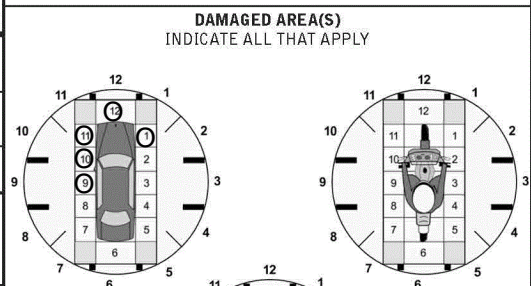

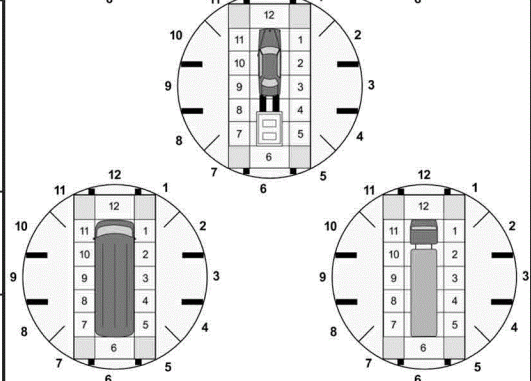

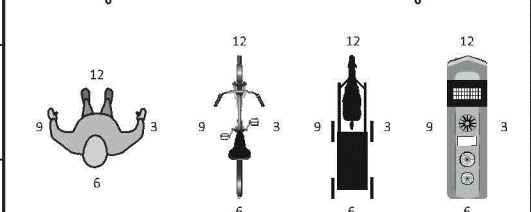
